Operational/ Strategic Planning	<ul> <li>To assist in the development of appropriate syllabuses, resources, schemes of work, marking policies and teaching strategies in the Curriculum Area and subject.</li> <li>To contribute to the Curriculum Area and subject development plan and their implementation.</li> <li>To plan and prepare courses and lessons.</li> <li>To contribute to whole school planning activities.</li> </ul>

Curriculum Provision:	To assist the Head of Ethics, Philosophy & Religion in ensuring that the curriculum area provides a range of teaching which complements the school's strategic objectives.
Curriculum Development:	To assist in the process of curriculum development & change, so as, to ensure the continued relevance to the needs of students, examining and awarding bodies and the school's strategic objectives.
Staffing Staff Development: Recruitment/ Deployment of Staff	<ul> <li>To take part in the school's staff development programme by participating in arrangements for further training and professional development.</li> <li>To continue personal development in the relevant areas including subject knowledge and teaching methods.</li> <li>To engage actively in the Performance Management Review process.</li> <li>To ensure the effective/efficient deployment of classroom support.</li> <li>To work as a member of a designated team, contributing positively to effective working relations within the school.</li> </ul>

Management of Resources:	<ul> <li>To contribute to the process of the ordering and allocation of equipment and materials.</li> <li>To assist the Head of Ethics, Philosophy &amp; Religion to identify resource needs and to contribute to the efficient/effective use of physical resources.</li> <li>To co-operate with other staff to ensure a sharing and effective usage of resources to the benefit of the School, Curriculum Area and the students.</li> </ul>

## Pastoral System:

- To be a Form Tutor to an assigned group of students.
- To promote the general progress and well-being of individual students and of the Form Tutor Group as a whole.
- To liaise with a Pastoral Leader to ensure the implementation of the school's Pastoral System.
- To register students, accompany them in assemblies, encourage their full attendance at all lessons and their participation in other aspects of school life.
- To evaluate and monitor the progress of students and keep up-to-date student records as may be required.
- To contribute to the preparation of Action Plans and progress files and other reports.
- To alert the appropriate staff to problems experienced by students making recommendations as to how these may be resolved.
- To communicate as appropriate, with the parents/carers of students and with persons or bodies outside the school concerned with the welfare of individual students, after consultation with the appropriate staff.
- To apply the Behaviour management procedures so that effective learning can take place.

## Teaching:

- To teach, students according to their educational needs, including the setting & marking of work, to be carried out by the student in school and elsewhere.
- To assess, record and report on the progress, development and attainment of students and to keep such records as are required.
- To provide, or contribute to, oral and written assessments, reports and references relating to individual students and groups of students.
- To ensure that ICT, Literacy, Numeracy and school subject specialism(s) are reflected in the teaching/learning experience of students.
- To undertake a designated programme of teaching.
- To ensure a high, quality learning experience for students which meets internal and external quality standards.
- To prepare and update subject materials.
- To use a variety of delivery methods which will stimulate learning appropriate to student needs and demands of the syllabus.
- To maintain discipline in accordance with the school's procedures, and to encourage good practice with regard to punctuality, behaviour, standards of work and homework.
- To undertake assessment of students as requested by external examination bodies, curriculum area and school procedures.
- To mark, grade and give written/verbal and diagnostic feedback as required.

## Other Specific Duties:

- To play a full part in the life of the school community.
- To support the school in meeting its legal requirements for worship.
- To promote actively the school's corporate policies.
- To continue personal development as agreed.
- To comply with the school's Health and safety policy and undertake risk assessments as appropriate.
- To undertake any other duty as specified by the Headteacher not mentioned in the above.

Employees will be expected to comply with any reasonable request from a manager to undertake work of a similar level that is not specified in this job description.
