

Teaching & Learning Update

It has been another fantastic week for learning. Over the last fortnight we have been able to see more students face to face, either in tutorials or in Year 10 maths and English lessons. We have also seen an increase in virtual live lessons. It has become increasingly clear that our students are demonstrating maturity and organisational skills far beyond their years during this uncertain period. We are extremely proud of the way students have responded to Learning@Home and can already see that they have built skills in independence and resilience that will see them through their school careers and beyond. Some highlights this week have been:

- Over 94% attendance for Year 10 English, maths and Tutorial sessions.
- Very high levels of engagement with the KS3 assessments this week. Results in so far show how much work students have been doing, as part of their Learning@Home.
- Some truly inspiring entries in response to our enrichment booklets. We thought Daisy French's artwork (right), entered in response to the Black Lives Matter enrichment booklet, was superb.





KS3 Assessment Week

Well done to all our students in Year 7-9 who took part in the KS3 assessments this week. We have been incredibly impressed with students' achievements given the current situation and the challenges of learning at home. These assessments will be vital to teachers, so they can continue to plan for this term, and crucially, make sure we plan effectively for students returning to school in September.

The assessments completed last week have focussed on the knowledge gained since the school closures and will now provide teachers with some information to plan the recovery curriculum needed next year. These assessments have also been completed now rather than in September to avoid further anxiety for students on their return to school.

We do appreciate that the Learning@Home programme and assessments have not been easy for some students and families and therefore we will continue to assess students' knowledge and understanding in September through lesson time rather than formal type assessments. If students have not achieved what they feel to be their full potential during these assessments, they should not worry as we appreciate the circumstances under which these have been completed. Over the next two weeks our students will receive their assessment marks from their teachers, and lessons will focus on feedback, addressing any misconceptions and gaps in knowledge from the Learning@Home programme. Work will continue to be set on ClassCharts as per the Learning@Home timetable with students in Key Stage 3 completing three hours of learning per day plus some form of physical activity.

Once again, thank you for your support and understanding as we make the most effective plans to support your child's learning over the coming months. Thanks, Mr Dudley


