3.1 Updates for Term 3 (January 2022)

In line with the recent Government guidance we will return in January in enhanced measures. The main areas from the guidance are as follows. Please see the relevant A to Z section for more details:

- Start and finish times should be staggered to reduce mixing between students. Therefore, the day will start for KS3 at 8.30am, and for KS4 at 8.40am. The school day will end at 3pm for KS3, and for KS4 at 3.10am. For full details see the 'School Day Timings' section.
- Face coverings will once again be required in all indoor areas, including classrooms, corridors and communal areas until further notice. Parents and carers must ensure that students attend school with 2 face coverings each day so that they are able to follow the guidance. Any children with exemptions previously advised by parents/carers should ensure they carry their exemption card at all times.
- Lateral flow testing to be undertaken even if students have tested positive for Covid in the last 90 days.
- From Tuesday 11th January, confirmatory PCR tests have been temporarily suspended following a positive LFT, so students should treat a positive LFT result as the start of selfisolation, without having to have an additional PCR.
- Since Wednesday 22 December, the 10 day self-isolation period for people who record a positive PCR test result for COVID-19 has been reduced to 7 days in most circumstances, unless you cannot test for any reason.
- People who are fully vaccinated, or children and young people aged between 5 and 18 years and 6 months, identified as a close contact of someone with COVID-19, should take an LFD test every day for seven days and continue to attend their setting as normal, unless they have a positive test result or develop symptoms at any time.
- Enhanced cleaning routines will be in place. Students should also ensure that they undertake enhanced hygiene routines, washing or sanitizing hands regularly. Please ensure that your child brings a small bottle of hand sanitizer with them for their personal use.
- Enrichment activities will continue to take place, but arranged by Year Groups.
- Trips, Residentials, Presentation/Celebration Events etc are suspended until further notice. Assemblies will take place online.
- Measures previously in place to reduce mixing:
 - Line-Up for Lessons
 - Separate food serving areas/catering points, social areas for Year Groups
 - Allocated toilets and gates for Year Groups
 - One-way systems in corridors
 - No face to face Parent/Subject Evenings
- In light of the predicted increased cases in the South West, and the potential knock-on impact on staff absence (due to staff positive cases or staff childcare) we have developed a specific contingency plan in case we are required to direct a Year Group to work from home remotely. To enable parents to make plans should this need to be put in place we have allocated specific Year Groups to specific days of the week in the hopefully unlikely event that we will need to action this contingency plan. For more information see the 'Contingency Planning' section.

3.2 Year 11 Updates

Following the Government guidance, we are planning for our Year 11 students to prepare for and undertake their PPE exams, alongside their work in lessons. This will give them the best opportunity to gain the results of which they are capable in their exams in the Summer 2022, or in Teacher Assessments, should they be required by the Government.

Year 11 students must ensure that they attend each day, work to their very best of their ability, challenge themselves to strive for their best results, and revise for their PPEs with focus and determination.

We have written to all parents/carers with details of the range of support in place, including mentoring, intervention, revision, study support, in class intervention and revision workshops etc. Please ensure that your child takes advantage of all these opportunities to support them towards getting their best results.

4 Amber/Enhanced Measures A to Z Guidance for Parents & Students

4.1 After School Clubs

Our students' opportunities for enrichment have been significantly impacted by Covid. We will continue to offer a full enrichment programme, however this will be arranged in Year Groups. Full details will follow in the next week. We are thrilled to be able to continue this vital part of our curriculum, and we know that students will be keen to get back to a range of exciting new clubs.

4.2 Arrival Information

Students should use their designated gate as follows:

- The Side Gate, on the footpath through school, for Year 9 and 11
- The Top Beech Grove Gate, nearest to the Park/Beech Grove, for Years 7 and 10
- The Top Mantle Street Gate, on the path leading to Mantle Street, for Year 8

Students are not able to enter via the Main Gate for any reason.

Students must not congregate in the park or paths around the site before their entry time. They may, if they are early (which we would ask students/parents to avoid if possible), wait on the path onto our school field.

Students should come on site no more than 10 minutes before the start of their registration time, and move directly to their Year Group Zone. Hand sanitisers will be available on entry and exit and should be used routinely by all students.

4.3 Attendance

We will expect, as per the Government guidance, all students to attend, and we will be required to follow our Attendance Policy. This includes the duty of parents to ensure that their children regularly attend school. Our school will, once again, be expected to follow up absences, and where appropriate issue sanctions on behalf of the Local Authority.

In the event that your child is unwell, we request you call school by 8am on each day of absence, and leave a detailed message regarding the reasons for your child's absence.

Should your child or anyone in your household display COVID symptoms you must inform us, so we can implement actions within our school risk assessments as well as provide support for the student(s) affected where appropriate.

If your child has been a close contact, they should undertake a PCR test and LFT test daily until they receive the result of that PCR test. If your child has a positive LFT result, they should undertake a PCR test urgently and we recommend that they self-isolate until they receive the PCR result.

4.4 Behaviour

The same expectations of behaviour apply as last Term. Our students responded with maturity and common sense to the various Covid guidance over the last 18 months. We expect them to do the same on they return from the 1st November. It is vital that they follow all guidance on social distancing, hygiene and the wearing of face coverings, as well as those regarding safety, kindness, and good manners. As always, we expect lessons to be about focussing on learning, and the highest standards of behaviour. Thank you for being clear with your child regarding this. We will also remind them of our expectations on their return to school.

4.5 Break & Lunch Times

Break and lunch times for students will be spent in an allocated social area with minimal mixing between Year Groups.

4.6 'Catch-Up'

Our experienced Heads of Faculty and subject teachers have adapted the curriculum to take account of time in and out of school. This might, for example, include changing the order in which knowledge is taught (sequencing) or including more opportunities to go back over work learned last year or during the lockdowns (retrieval practice). This process will continue, to ensure that your child has the best opportunity to develop the knowledge and skills that they need, and to enable them to know more, remember more, or do more as a result.

The Government's 'Catch Up' Programme

The Government assigned each school funding to assist with the cost of interventions designed to ensure no student suffers underachievement as a result of Coronavirus school closures. Full accountability for all funding and the impact of its use will be required by OFSTED. We have already discussed our plans with them as part of our recent Ofsted visits in February and June 2021. They validated the plans that we have put in place as appropriate to support the progress of our students. We will continue to review, evaluate and plan for further support as appropriate over the coming months.

If you have any questions regarding Catch-Up funding please contact your child's Head of Year in the first instance.

4.7 Classroom Routines

Classroom routines around sanitising both hands and workspaces and utilising silent or settled starter activities remain as per the autumn term. For further information, please see the previously issued staff or parent guides.

4.8 Close Contacts

The Government Guidance published on 2nd January 2022 is as follows:

Daily testing for close contacts of COVID-19

People who are fully vaccinated, or children and young people aged between 5 and 18 years and 6 months, identified as a close contact of someone with COVID-19, should take an LFD test every day for seven days and continue to attend their setting as normal, unless they have a positive test result or develop symptoms at any time.

We will continue to identify close contacts within school, although we are not required to do so, as we have been advised by Public Health that this may have had a significant impact in reducing chains of transmission over the last term.

4.9 Contingency Planning

In the Event of Full or Partial Closure:

The Government has advised that it is unlikely that we will go back to a full closure of the school. Before this happens, a partial closure may be put in place, although again this is unlikely. In order to ensure a contingency is in place for either of these eventualities we have planned for either full or partial closure as follows:

- We will follow the process as in the January 2021 Lockdown with predominantly live lessons, complemented by online work.
- All work will be set via Class Charts and students will be expected to upload completed work here as well
- · The school's feedback policy will remain in place, and feedback will be given at least every 6 lessons

To ensure students do not fall behind, the work set will follow the normal schemes of learning that the school has in place and will take place at the same time.

The times of live lessons will be shared with students in advance via Class Charts along with instructions for joining the lesson. Live lessons may not last for the entire lesson time. In these cases, follow up work will be set and students will be asked to upload this to Class Charts.

It is vital that students follow their normal timetable in the event of another lockdown in order to avoid falling behind. Work will be set and live lessons scheduled during the normal slot for that subjects lesson. In order to protect the privacy of our students, live lessons must not be recorded. Parents and other adults should not be present (i.e. in the same room) for the Live lesson.

If a specific Year Group is required to work from home via Remote Learning

If levels of staff absence on any given day reach a critical level we will make the decision to send a year group home. We will use the normal means of communication to alert parents, as we would for adverse weather (text message, email and social media etc.) We will alert parents by no later than 7.45am Should we need to do so this would be on a pre-arranged schedule by day as follows.

Monday/Tuesday: Year 8
Wednesday/Thursday: Year 9

Friday: Year 10

This will allow parents to plan in advance for childcare, allow vulnerable students to be prepared for changes and allow staff to plan in advance and therefore ensure the quality of remote learning being set. If a year group is learning remotely for a day, the work set will focus on retrieval and revision of prior learning and ensuring the retention of essential knowledge and concepts; no new learning will be introduced while students are working from home on a short term basis. This is to ensure that no student is disadvantaged by temporary remote learning.

4.10 Face Masks and Face Coverings

New guidance from the DfE recommends that staff and students in Year 7 and above wear face coverings in all indoor areas of the school and when social distancing cannot be maintained as follows:

Updated guidance on the use of face coverings in education settings

From today, Sunday 2 January, it is recommended that face coverings are worn in classrooms where pupils in year 7 and above are educated. The advice is short term only, to support pupils and teachers as they return to school this term and builds on the existing proportionate guidance that recommends face coverings for all adults in communal areas of all settings. We are updating our guidance to reflect this. The advice on face coverings in classrooms will be in place until Wednesday 26 January, when Plan B regulations are currently scheduled to expire, at which point it will be reviewed.

Students who are exempt from wearing a face mask will be issued with an exemption card. All staff will be issued with a regularly updated list of exempt students. However, if staff see a student without a mask, they will challenge the student in a non-confrontational way and ask to see their exemption card. Students not wearing masks without an exemption card will be logged on class charts using the 'no face mask' button and this will be discussed with the student and Tutor, or parents may be contacted in repeat circumstances.

What face covering will students need?

We'd recommend a reusable one so that they can use it more than once, as they'll need to take it on and off several times during the school day. If this isn't an option, they will need to bring in several single-use face coverings each day. Their face covering should be secured to the student's head using ear loops only. A sealable plastic bag to keep their face covering in when student's not using it so that it doesn't contaminate (or get contaminated by) other surfaces in school

How should students use their face covering?

The face covering needs to cover students nose and mouth when they're wearing it. Students shouldn't touch the front of the face covering or the part that's touched their mouth or nose. Students should wash their hands before and after touching the face covering, including to take it off or put it on. They should store it in an individual, sealable plastic bag between uses. If it becomes damp, they shouldn't wear it, and they should replace it carefully. Single-use face coverings should be disposed of after use (not in a recycling bin). Use 'Catch it, Bin it, Kill it' guidelines.

How often will it need to be washed?

Reusable face coverings will need to be washed at the end of each day, ready for your child to wear the next day. If a student has taken a spare reusable mask from school, this will also need to be washed before they use it again. Students can wash and dry reusable face coverings with normal laundry – follow the washing instructions for the fabric and use normal detergent

What if a student is exempt from wearing a face covering?

In this event we have requested parents let us know, by contacting your child's Tutor on email, or via our main email sch.552@educ.somerset.gov.uk if a child is exempt so that we don't ask them to wear a face covering

What if a student forgets their face covering?

We'll have a small supply of spares available at school, but these will be for emergencies only. To be safe in the knowledge that everyone has one, parents must make sure their child has their own, so that we can keep our supply of spares for emergencies.

4.11 First Aid

We will be running **emergency First Aid support only** from the Hub during the school day, and as for last Term, have allocated a First Aid room (the Hub) and COVID Isolation space. **Students should only attend First Aid if they are persistently unwell, having informed their teacher who will give guidance on when they should go to First Aid. In the event that it is not an emergency, this advice may be that they should wait until break or lunchtime.**

I'm sure that you will understand that this means that we cannot support students with, for example, a 2 day old muscle sprain, or a mild headache. Students should only access First Aid in an emergency, which would include Covid symptoms, and this should be before school, at break or lunch. Students should not be accessing First Aid in lessons unless they are displaying clear Covid symptoms (which they were not displaying before school, at break or at lunch). Students accessing First Aid for reasons other than emergencies, places themselves at risk, as they may be more likely to be exposed to infections.

In the event of a student displaying COVID-19 symptoms they will be isolated, and parents/carers informed to come and collect. Once a student arrives, they must wait outside the Hub and the first aider will ask if they are displaying COVID-19 symptoms, if they are, they will be immediately directed to the isolation area. The first aider will put on full PPE and access the isolation area to assess.

If a student requires non COVID-19 treatment they can only attend during break and lunch on their own. Students should only leave lessons if they display COVID-19 symptoms or in an emergency.

In the event of an accident or emergency, we have a number of first aiders on site who will be alerted and will provide medical attention. In the event of a student displaying COVID symptoms they will be isolated and parents/carers informed to come and collect. Regular cleaning will take place of the First Aid area.

4.12 Health, Safety & Hygiene

Ensuring the Health and Safety of students is of paramount importance and our full risk assessment has been prepared to respond to the range of risks and controls in the school environment. This will continue to be available on the website.

All rooms being used will be cleaned during the day in between use, and then thoroughly at the end of the school day. Students will be encouraged to wash hands regularly and specifically before and after eating. Signage will be displayed around the school to enforce this approach. Each classroom will have a bin for the disposal of tissues or waste during the day, and this will be emptied regularly.

We would ask all students to bring hand sanitiser with them to school. Although, as last term, hand sanitisers will be available outside every teaching room, and around the site, the wearing of masks in class will mean

that students must have their own sanitiser to use, for example if they touch their mask. All other hygiene aspects will remain as they were last term.

If any pupil displays COVID-19 symptoms during their time in school, they will be isolated in the COVID-19 Isolation area, adjacent to the Hub, prior to collection by parents. Children must be kept at home if they or any member of the household has COVID-19 symptoms. Please follow government guidance if you are unsure.

We also, in line with Government guidance, will expect all staff and families to engage with the NHS Track & Trace process. In line with Public Health England guidance, we have a plan in place in the event of confirmed COVID-19 cases and will continue to liaise with parents/carers as last term.

In order to support the Amber guidance, non-practical classrooms will be arranged with rows of desks facing the teacher, who should maintain a social distance from the students where possible. Each Year Group has been allocated their own toilets to prevent students from different Year Groups mixing, and these will be cleaned on a regular basis throughout the day.

The use of additional hand washing or hand sanitising is a key element of the Government's published prevention strategy for Covid-19. In line with this we would expect students to clean their hands throughout the day. There will be students who may experience skin irritation or cannot use specific products due to medical reasons, and if this is the case we would request that you contact your child's Tutor by email directly or via the main school email.

4.13 Homework Club / KS4 Study Group

If your child wishes to attend Homework Club after school, they should simply go to the following locations:

- Key Stage 3 in the LRC
- · Key Stage 4 in B1

4.14 Illness in School

In line with the Government Covid guidance regarding attendance, students can only be sent home for Covid reasons, if they display one of the main COVID symptoms:

- a high temperature this means the student feels hot to touch on their chest or back
- ➤ a new, continuous cough this means coughing a lot for more than an hour, or 3 or more extended coughing episodes in 24 hours
- ➤ a loss or change to your sense of smell or taste this means you've noticed you cannot smell or taste anything, or things smell or taste different to normal

If a student is displaying any of these symptoms they will be sent to First Aid immediately.

Please note that First Aid is for emergencies only, and that students should not be allowed out of a lesson to access First Aid unless for the reasons above, or an emergency.

Please see the First Aid section in the Appendix for full First Aid details.

4.15 Litter

In response to government guidance and 'Catch It, Bin It, Kill It' we have ensured that all classrooms and communal areas have plenty of bins provided. It is vital that all students put rubbish directly into the bins to prevent any cross contamination. We need to ensure we have a clean and tidy site at all times. Should students not be able to locate a bin within their zone they must let a member of staff know immediately. In a lesson, students should put up their hand to ask the teacher's permission to put litter in the classroom bin, as is normal courteous practice.

4.16 Lockers

Students who wish to have access to a locker should contact their Tutor. The vast majority of lockers have been allocated already this year, with a small number yet to be allocated. If you have ordered a locker, and this has not yet been allocated, please contact your child's Tutor.

4.17 Lost Property

In the that event equipment or uniform is left, it will be returned to the Hub. This will be checked daily, and all named items returned directly to the student. If an item is unnamed it will remain in the Hub for two weeks to be claimed. Any unclaimed items may be disposed of/sent to charity.

Please ask your child to ensure they look after their belongings and ensure that all items of equipment and uniform are clearly labelled.

4.18 Learning Resource Centre (LRC)

Students are able to continue using the LRC. After school use is arranged with KS3 in zoned areas of the LRC and KS4 in B1. Break and lunch will be arranged in zones in the LRC.

Students can still use the LRC to return and borrow books. We will employ enhanced sanitising routines and a quarantine system for returned books.

4.19 Lunchtime Serving Areas

Meals will continue to be available from the same areas as last term as follows:

4.20 Movement around School

One-way systems are in operation in B Block, C Block and E Block.

Students will line up for lessons outside. They should ensure that they are prompt and calmly lined up ready for learning.

4.21 Parents' Evenings

These will continue using the phone call format that we have successfully used through the Academic Year to date. We will advise with further information as we receive it from Public Health on larger scale events later this term.

4.22 Risk Assessment

Since March 2020, we have been assessing all risks and implementing strict control measures in order to limit the transmission of coronavirus (COVID-19). We have revisited and updated our risk assessments as we return to full capacity and we will continue to review and update these in line with Government guidance.

4.23 Self-Isolation

The Government Guidance published on 2nd January is as follows:

Information on the changes to the self-isolation period for individuals who test positive for COVID-19 Since Wednesday 22 December, the 10 day self-isolation period for people who record a positive PCR test result for COVID-19 has been reduced to 7 days in most circumstances, unless you cannot test for any reason.

Individuals may now take LFD tests on day 6 and day 7 of their self-isolation period. Those who receive two negative test results are no longer required to complete 10 full days of self-isolation. The first test must be taken no earlier than day 6 of the self-isolation period and tests must be taken 24 hours apart. This also applies to children under 5, with LFD testing at parental or guardian discretion. If both these test results are negative, and you do not have a high temperature, you may end your self-isolation after the second negative test result and return to your education setting from day 8.

Anyone who is unable to take LFD tests will need to complete the full 10 day period of self-isolation. Further information is available in the <u>stay at home: guidance for households with possible or confirmed COVID-19 infection.</u>

Please continue to inform the school using the Covid+ button on ClassCharts and the confidential@courtfields.net email to report self-isolation due to your child testing positive for Covid, or displaying Covid symptoms.

4.24 Shielding Work

In the event that students need to shield during the Autumn Term, work will be set on Class Charts. To access this work, students should search by <u>due date</u> and should scroll through to the 17th of December. All Shielding work will be set with the code 'SHLD' at the start. i.e. English work will be set as 'SHLD English' Work completed can be emailed to class teachers or uploaded to Class Charts.

Students will be permitted on the tennis courts and field area as follows (weather permitting)

- Year 7 -10 on the tennis courts (ball games only)
- Year 11 on the field (weather permitting)

If the field is not accessible due to wet weather, Year 8-11 will be allocated to the courts and Year 7 to the E Block playground (supervised small group games).

4.26 Student Access to the Hub

No student should go the Hub during lesson time expect in a medical emergency. We need to encourage a focus on learning and encourage students to use the 'drop-in' at the Hub at break and lunch for support if they need it.

4.27 Student Resources

Please can we remind all parents and students that they are responsible for ensuring that they have a full set of equipment. This includes a suitable number of pens and pencils, a ruler, a calculator, maths equipment such as protractors and compasses and colouring pencils.

We will not be able to lend equipment easily due to difficulties around equipment sharing. Pens can be loaned in exceptional circumstances, however, due to restrictions around equipment sharing and the need for sanitising of loaned items, this is problematic and should be avoided if possible. Additional specialist equipment will, of course, be provided as normal and sanitised in line with our risk assessment.

Year 7 students have all been provided with a stocked pencil case as part of their Induction Goody Bag. This should simply be kept stocked and brought to school each day. All other Year Groups should provide their own equipment and bring this with them to each lesson. Tutors will run full equipment and uniform checks each morning to ensure students are prepared for the day. Pencil cases with a set of basic equipment will be on sale at a cost of £1.50.

Unless they have been requested for marking, students will be responsible for their own exercise books, to limit cross contamination through handing books in and out. As students will be moving around school substantially less than normal and the need for specialist equipment has been reduced, they should be able to carry all books needed for each lesson. It is vital that students check their timetable each day (or ideally the day before) and ensure they have the correct books in their bags. The handing out of paper is problematic and should be avoided if possible.

4.28 Student Zones

Student Zones remain unchanged from last Term.

4.29 Testing

The updated guidance from the Government is as follows:

As all settings are aware, we have asked that secondary school students undertake one on-site test, on return in January. This will help boost testing participation and reduce transmission after a period of social mixing during the holidays. Students should then be strongly encouraged to continue testing twice weekly at home and to report all results to NHS Test and Trace and to their setting.

Further education and higher education students, and staff in all education and childcare settings, should take one self-test at home either the evening or morning before they return in January, then continue to test twice weekly at home. Colleges should continue to make LFD tests available to students and staff who need them to enable them to test prior to, and at, the start of term.

Even if someone has tested positive for COVID-19 within the last 90 days, they are strongly encouraged to take part in LFD testing on-site through ATS or at home once they have completed their isolation period for their prior infection.

As you may be aware there have been some shortages of Lateral Flow Tests and due to this we would ask that parents use the online test kit ordering system via the NHS to order test kits for their child, so that we can ensure that we have enough resources for in-school or emergency testing.

The Government has also announced temporary changes to the requirement to get a PCR test following a positive Lateral Flow Test as follows:

Confirmatory PCR tests following a positive lateral flow device (LFD) test result are to be temporarily suspended from Tuesday 11 January. This will mean that anyone who receives a positive LFD test result will be required to self-isolate immediately and will not be required to take a confirmatory PCR test.

4.30 Timings of the School Day

The slight change to timings of the day for Covid whilst we remain in 'Amber'. We continue with the slightly reduced lunch, and stagger the start and end times for KS3 and KS4 tutorial. The times of the day will be as follows:

Structured tutor time activities, including Personal, Social, Heath & Careers Education (PSHCE – formerly PD) will apply for all Year Groups, including live assemblies via video link.

4.31 Toilets

- Year 7 will use the Sports Hall toilets (break/lunch only) and E Block toilets (between lessons only in an emergency)
- Year 8 will use the C Block toilets (Art side)
- · Year 9 will use the C Block toilets (Nugget side)
- Year 10/11 will use the toilets in B Block (Science Corridor).

4.32 Transport

As always, we would encourage all students, where possible, to travel to school on foot, or by bike. We have limited drop-off facilities at the front of school, and only students with mobility issues will be able to be dropped-off/collected at the front Reception car park. If parents do need to drop-off/collect their children, they should do so by the Youth Centre as close to the students' arrival time as possible. Please do not park in the spaces outside the Youth Centre (which are not allocated to our school) or block access to parents collecting from the Court Fields Pre-School.

Students on dedicated school bus services must wear face coverings on transport, and follow any other guidance communicated directly by these providers. If your child uses a dedicated school bus service, please ensure that you have checked the detail of their arrangements with the provider directly. Students using public transport should refer to the safer travel guidance for passengers.

4.33 Uniform

Once again, all students should return in full school uniform. This will include the school blazer. To reduce the risk of aerosol transmission of the virus we will keep the classrooms well ventilated. With this in mind, students may wish to wear a long-sleeved plain white t-shirt under their uniform.

Thank you for your support in reducing the number of short stretchy jersey type skirts, which are too short and inappropriate for school. Please continue to support us by ensuring that your child wears an appropriate tailored skirt or school trousers.

Full PE kit is expected for every PE lesson. We are unable to lend kit and the failure to bring kit may result in being sent home. Please see our website for the full uniform guidance. All uniform is available via Taunton Uniforms.

As always, hair colour must be natural, we do not accept non-natural colours. Only one set of stud earrings is permitted, all other ear and facial piercings must be removed during school hours. We do not allow clear retainers for piercings. Thank you for your support in reducing the number of students with inappropriate piercings or jewellery. Please continue to monitor this with your child.

School shoes must be plain black and polishable. Canvas, suede, material trainers, those with obvious air bubbles or including any colours other than black, are not allowed in any form. Boots, 'dolly', platform, or block-heeled 'Mary Jane' type shoes are not allowed. Socks must be black. Thank you for your continued support.

4.34 Vaccinations

The Government has issued the following information on vaccinations for 12 to 15 year old students:

Around half of 12 to 15 year olds have now received at least one dose.

Young people aged 12 to 15 in England are now being offered a second dose of the Pfizer-BioNTech COVID-19 vaccine at a minimum of 12 weeks from the first dose, following advice from the Joint Committee on Vaccination and Immunisation (JCVI).

Parents can book vaccinations for their child, if aged 12 or over, through the NHS booking system.

Vaccination for this group will also continue to be carried out by the school age immunisation service (SAIS).

We will update parents as soon as we have more information on the 2nd dose via the in-school vaccination programme.

4.35 Ventilation

Research has indicated that ventilation plays a key part in reducing the risk of the transmission of Covid in indoor spaces, such as classrooms. The Health & Safety Executive are clear that 'adequate ventilation reduces how much virus is in the air, and therefore reduces the risk from aerosol transmission for people in that area'.

In order for us to reduce the risk of this 'aerosol transmission' we will put in place the following measures:

- Windows will be kept open at all times in classrooms and communal indoor areas (such as the Hall). During these spring months this will involve windows being partially open, or if colder, just open a crack.
- For 10 minutes every 30 minutes windows will be opened more fully to provide a 'flushing' of the air in the room, which research suggests plays a significant role in reducing transmission.
- Staff will also ensure that they take steps to achieve the most effective ventilation, for example opening blinds fully, opening top windows and leaving the classroom door open (unless this is a Fire Door. Staff will, of course, balance this ventilation against the comfort of students in the room, and ensure that if the weather is cold, windows remain open only a small amount.

Please do discuss with your child the necessity for this ventilation, particularly in classrooms, and ensure that they are appropriately prepared if the weather is a little colder, for example with a vest or plain long white sleeved T-Shirt under their school shirt. They should also have their school jumper to provide an additional layer in colder weather.

4.36 Visitors

We will continue to minimise the number of visitors onsite, so please continue to call or email the office if you have any queries to avoid unnecessary visits to the school premises.

Appointments or meetings will continue to be undertaken where possible by phone or online via Microsoft Teams. Please do not come onto site to meet your child unless they are ill and need collecting. In the event a forgotten essential item needs to be brought to school, for example PE kit or lunch, we will request you come to the main entrance and place the item in the drop off zone and call 01823 664201 to inform staff the item has arrived, we will then arrange for the student to collect. Please do not enter the school building.

4.37 Wellbeing & Support

Students' Tutors, Heads of Year and our Pastoral Support Team will continue to support all our students. If you have any concerns about your child's wellbeing please do contact your child's Tutor, who will be able to advise and help support. If necessary they will escalate to the Head of Year or Pastoral Team. If you have a safeguarding concern regarding your child, or another student, please do contact us on our dedicated email: safeguarding@courtfields.net

Of course, some worry or anxiety is 'normal' given all that has happened over the last year. The key is to help our students normalise their feelings and be able to develop strategies to overcome those worries. This has been covered in Tutor activities and PSHCE sessions, and also through advice from our staff in the Hub.
