For 1st September 2025, we are seeking to appoint an energetic and driven individual who is passionate about teaching and learning in order to support the school's aim of achieving high results, consistently excellent classroom practice and developing literacy across the curriculum.

The successful candidate will work in a supportive environment and provide effective and engaging learning opportunities that meet the needs of all students. Applicants will be highly motivated and have a passion to ensure that our learners achieve the very best that they can at all times. The core purpose of the role will be to uphold the fundamental standards of **pride, respect** and **achievement** with all learners but also ensure that all students receive the highest standard of bespoke support.

As well as being an excellent classroom practitioner the successful candidate will be responsible for whole school literacy and will work with colleagues across the curriculum to ensure literacy is embedded across all subjects and that students routinely have high quality opportunities to develop their literacy skills further.

We are seeking applicants who are:

- Passionate about teaching and learning and able to motivate students to embrace challenge to achieve their full potential
- Excited by making a difference to the experience young people have at school
- Consistently effective and reliable
- Highly reflective in their own practice
- Enthusiastic, positive role models who are able to work well with colleagues and demonstrate strong leadership qualities

In this role you will:

- Be part of the decision making and the direction of the school in relation to whole school literacy
- Use skills in monitoring and evaluating the quality of work around reading and writing in order to identify best practice in the school
- Work with colleagues to reflect on, discuss and learn from the best practice in order to raise standards
- Plan and lead staff training

You will be responsible for:

- Developing initiatives in school to promote reading for pleasure
- Develop and monitor initiatives to improve students with weak reading skills, particularly fluency and comprehension
- Develop and monitor initiatives to promote extended writing and SPaG skills
- Liaising with curriculum teams across the school to evaluate how well wider reading is embedded into schemes of learning
- Work closely with the senior team to facilitate literacy focused professional development

Purpose of the role (job statement)

Carry out the professional duties of a teacher as circumstances may require and in accordance with the school's policies under the direction of the Headteacher

To be an effective professional who demonstrates thorough curriculum knowledge, can teach and assess effectively, take responsibility for professional development and has students who achieve well

Carry out the duties of a classroom teacher as set out in the School Teachers Pay and Conditions Document and to meet the core Professional Standards for Teachers contained within the Framework in the STPCD. In addition, if paid at the upper pay scale meet post threshold standards.

Responsibilities

To carry out Planning, Teaching and Class Management: to teach allocated students by planning their teaching to achieve progression of learning through:

- identifying clear teaching objectives and specifying how they will be taught and assessed
- setting tasks which challenge students and ensure high levels of interest
- setting appropriate and demanding expectations
- setting clear targets, building on prior attainment
- be aware of and make provision for students who are AEN/SEN, very able, LAC or who have other particular individual needs
- providing clear structures for lessons maintaining pace, motivation and challenge
- making effective use of assessment and ensure coverage of programmes of study
- ensuring effective teaching and best use of available time
- maintaining discipline in accordance with the school's procedures and encouraging good practice with regard to punctuality, behaviour, standards of work and homework using a variety of teaching methods to:
 - i. match approach to content, structure information, present a set of key ideas and use appropriate vocabulary
 - ii. use effective questioning, listen carefully to students, give attention to errors and misconceptions
 - iii. select appropriate learning resources and develop study skills through library, ICT and other sources
- ensuring students acquire and consolidate knowledge, skills and understanding appropriate to the subject taught
- evaluating own teaching critically to improve effectiveness
- ensuring the effective and efficient deployment of classroom support
- liaise with the Subject Leader to ensure the implementation of department policy and best practice

Monitoring, Assessment, Recording, Reporting

- assess how well learning objectives have been achieved and use them to improve specific aspects of teaching
- mark and monitor students' work and set targets for progress
- assess and record students' progress systematically and keep records to check work is understood and completed, monitor strengths and weaknesses, inform planning and recognise the level at which the student is achieving
- undertake assessment of students as requested by examination bodies, departmental and school procedures
- prepare and present informative reports to parents
- undertake assessment of students and participate in the school's system reporting to parents

Curriculum Development

- contribute to the development, implementation and evaluation of the school's policies, practices and procedures in such a way as to support the school's values and vision
- work with others on curriculum and/or pupil development to secure co-ordinated outcomes

Pastoral Duties

- be a Form Tutor to an assigned group of students
- promote the general progress and well-being of individual students and of the Form Tutor Group as a whole
- liaise with the Pastoral Leader to ensure the implementation of the school's pastoral system
- register students, accompany them to assemblies, encourage their full attendance at all lessons and their participation in other aspects of school life
- contribute to the preparation of action plans and progress files and other reports
- alert appropriate staff to problems experienced by students and make recommendations as to how these may be resolved
- communicate, as appropriate, with parents of students and persons or bodies outside the school concerned with the welfare of individual students, after consultation with appropriate staff
- contribute to PSHE and citizenship and enterprise according to school policy
