St Edmund's Catholic Academy is an inclusive school and has students with Special Educational Needs and Disabilities (SEND) across all Key Stages, so from Key Stage 3 – Key Stage 5, aged 11 to 18.

This document intends to support parents of students with SEND. SEND encompasses the four areas of need: Cognition and Learning, Communication and Interaction, Physical and/or Sensory and Social, Emotional and Mental Health.

### **What is the SEND Information Report?**

This is a report produced by each school and made accessible via the school’s website and the relevant Local Authority website.

### **How do I give a compliment or make a complaint about the SEND provision at St Edmund’s Catholic Academy?**

### **SEND Provision at St Edmund’s Catholic Academy**

At St Edmund’s Catholic Academy, we have an informative SEND register which is accessible by all staff. We have students with a range of SEND, including students with an Educational Health Care Plan (EHCP) and students who are categorised as SEND Support.

EDEN is our SEND base in school and our Assistant SENCO is based in there every morning. Teaching Assistants (TAs) are based in EDEN during the afternoons. As well as support during lessons, SEND students have the option to attend EDEN during social times if they struggle with the other options available to them, such as the Courtyard.

All students with an EHCP will be invited for an Annual Review so progress can be discussed with parents/carers, school, any external agencies involved and the Local

Authority where applicable. Students are involved in the preparation and implementation of these meetings.

Key SEND information is shared during the transition between Primary and Secondary school and it is intended that any successful provisions will continue, where appropriate.

If any potential SEND issues are raised during a student's time at St Edmund's, the SENCO would follow the appropriate procedures. These procedures may include lesson observations, meeting with the students and/or parents, referring to external agencies for support or assessments and/or advising parents to visit their GP. Parents will be kept informed and will also be updated if their child has been added to or removed from the SEND register.

All parents of children with SEND are welcome to make an appointment with the SENCO during Parents Evening, which is an opportunity to discuss any queries, concerns or areas of achievement.

SEND provision at St Edmund's follows the graduated approach:

1. **Assess** – a clear analysis of a student's needs
2. **Plan** – a clear collection of smart, timely interventions that will be put into place
3. **Do** – the interventions set out during the 'plan' stage are implemented
4. **Review** – the interventions are reviewed in terms of their impact and recommendations are made regarding next steps

### **How is SEND provision monitored and reviewed?**

Reviewing pupil progress will be made at each data collection as well as regular monitoring of targets for those receiving withdrawal interventions. The review process will evaluate the impact and quality of the support and interventions. The SENCO will revise the support in light of pupil progress and development; making any necessary amendments going forward, in consultation with parents and subject teachers.

## **Expertise and Training of Staff at St Edmund’s Catholic Academy**

Staff at St Edmund’s Catholic Academy receive regular training to enable them to support the students in school to the best of their ability. These SEND based training sessions are organised and sometimes led by the SENCO, but on occasion involve input from external agencies. In the 2022/2023 academic year, staff were offered the following SEND based training:

- **Supporting students with Autism (Level 2)** – two sessions took place based on 1) communication and 2) flexibility, developing staff awareness and suggesting useful strategies to implement in the classroom and around school (provided by Wolverhampton Outreach)
- **Subject-specific Adaptive Teaching strategies** – staff were split into three groups: written subjects, practical subjects and Maths, and were provided with subject specific information and advice regarding adaptive teaching strategies (provided by Wolverhampton Outreach)

Over the 2023/2024 academic year, further SEND based training sessions will be provided which will focus on a variety of needs.

In addition to this, all staff have access to National College, which includes various CPD courses for staff to engage in, including many SEND based courses.
