Successfully treating the root causes of absence and removing barriers to attendance, at home, in school or more broadly requires families, schools and local partners to work collaboratively. Our aim is to build strong relationships with families, listen to and understand barriers to attendance and work with families to remove them. We will always take into consideration individual needs.

Working with Families

If a child has been absent from school on a number of separate occasions, we may write to you or seek to speak with you to notify you that their overall attendance percentage is decreasing. This is not to be seen as a negative communication but rather a way of us keeping you informed of what our data is telling us and a reminder that should you, or your child, have any concerns around attending school you are welcome to come in and discuss this with us. We will always try to help wherever we can.

Our letter process starts by advising families of a reduced level of attendance; however further absence will result in a second letter which will invite you to come into the school for a discussion.

Genuine illness will be recorded as authorised however, repeated illness related absences will need to be evidenced, and we may require extra information to enable us to continue authorising the absences.

Parents are encouraged to refer to the 'Is my child too ill for school' guidance published by the NHS in relation to common medical conditions. This information can be located on the NHS website <https://www.nhs.uk/live-well/is-my-child-too-ill-for-school/>

We will always aim to work with parents to resolve any attendance difficulties however in cases where we have undertaken many unsuccessful attempts we will seek the involvement of the Education Engagement Service (EES).

Levels of Attendance

Rewarding positive attendance

Good attendance is acknowledged through assemblies, attendance certificates and positive reward points. Student attendance is also analysed on an individual basis which takes into consideration individual needs. Therefore good attendance is also acknowledged on individual merit which may be outside of the designated figures.

Persistent absence

Absence that continues in spite of school support and measures is classed as **Persistent Absence**. This includes:

- Any child who has 3 days absence or 6 sessions* in a 30 day period
- Any child who has below 90% absence

Severe Absence

A student is classed as having severe absence if they are absent from school more than they are present (over 50%). Students who fall into this bracket will need intense support and a collaborative approach from multi agencies. The Academy will work with families, agencies and the Education Safeguarding Service in providing specific support.

Punctuality

Being late to school can also have a considerable impact with regards to student attainment. The table below shows just how much time can be missed over a year by being just 5 minutes late to school every day:

5 minutes late every day = 3 days of school lost a year
10 minutes late every day = 6.5 days of school lost a year
15 minutes late every day = 10 days of school lost a year
20 minutes late every day = 13 days of school lost a year
30 minutes late every day = 19 days of school lost a year

Request for Term Time Leave

Leave during term time is strongly discouraged due to the inevitable disruption caused to the educational progress of individual students and school staff.

All requests for term time leave should be submitted at least 4 weeks in advance using the 'Term Time Leave Request Form' which can be located in the attendance section of the Academy website. In the exceptional cases where a decision is made to authorise leave during term time, families are reminded that this is only for the period in question at the time and so it should not be assumed that authorisation will be granted for any future request.

Where a period of unauthorised term time leave is taken, whether this has been requested or not, please note that you may be at risk of a £60 per child, per parent fine from Somerset County Council. Further details of the prosecution process are available on their website: Somerset County Council - Attendance and Missing Education.

The Law

Regular attendance at school is important. Failing to attend school regularly can have a major impact on children's education, their future and their life chances. Regular attendance means attending school every day, arriving at school on time and attending every lesson.

Under section 7 of the Education Act 1996, parents are responsible for ensuring their child (from age 5 to age 16) receives efficient full time education that is suitable to the child's age, ability and aptitude and to any special educational needs the child may have. This can be through regular school attendance or through elective home education (EHE)

If a child who is registered at a school fails to attend regularly and there are no legitimate reasons, then parents are guilty of an offence under section 444 of the Education Act 1996. If convicted, parents will be liable to a fine up to £2500 or a prison sentence of up to 3 months, Magistrates may also impose a Parent Order.
