Year 11 Drama Trip - A Christmas Carol Theatre Trip – Monday 16th December 2024

As part of their GCSE, Drama students are offered the opportunity to watch live theatre to enable them to write a live review for their final exam. The work emanating from it is worth approximately 15% of their overall GCSE grade. 'A Christmas Carol' is our chosen play, as it will also support your son or daughter in their English GCSE.

We will be leaving school at approximately 5.45pm, to watch the 7.30pm performance at the **Theatre Royal, Bath** and will be travelling in the school minibus. Students are advised to eat before we leave or can bring a packed lunch to each on the journey. The performance lasts for approximately one hour, 40 minutes so I anticipate departing from Bath at around 9.20pm, therefore, arriving back at school at approximately 10.20pm depending on the traffic. Please arrange to collect your child at that time.

The cost of this trip will be £24. If you are in receipt of any of the following benefits the cost of this curriculum based the trip will be met by the Academy:

- income-related Employment and Support Allowance
- support under Part VI of the Immigration and Asylum Act 1999
- the guaranteed element of Pension Credit

- Working Tax Credit run-on paid for 4 weeks after you stop qualifying for Working Tax Credit
- Universal Credit if you apply on or after 1 April 2018 your household income must be less than £7,400 a year (after tax and not including any benefits you get)
