## Year 8 Educational Trip to Shepton Mallet Prison - Tuesday 21st January 2025

We have a fantastic opportunity to take some of our Year 8 students to the historical site of Shepton Mallet Prison on **Tuesday 21**<sup>st</sup> **January 2025.** 

The trip is an excellent opportunity to visit and learn about the oldest prison in the UK and complements our current Unit of Crime, Punishment and Non-Fiction Writing. The prison offers a fantastic KS3 Educational Programme.

Students will travel by coach to the event, leaving school at 9.15am and returning to Ansford Academy by 1.45pm in time for students to have lunch and attend period 5.

Students should wear their school uniform for the trip but dressing appropriately for the weather with an overcoat and scarf. Students may also like to bring a small amount of spending money as there is a shop selling branded merchandise and snacks.

The total cost of the trip, to cover the ticket and the coach, is £18.50.

In some circumstances, the Academy may be able to cover the cost of the trip, please contact Helen Martin. In order to be considered, you must be in receipt of one/some of the following benefits:

- Income Support
- income-based Jobseeker's Allowance
- income-related Employment and Support Allowance
- support under Part VI of the Immigration and Asylum Act 1999
- the guaranteed element of Pension Credit
- Child Tax Credit (provided you're not also entitled to Working Tax Credit and have an annual gross income of no more than £16,190)
- Working Tax Credit run-on paid for 4 weeks after you stop qualifying for Working Tax Credit
- Universal Credit if you apply on or after 1 April 2018 your household income must be less than £7,400 a year (after tax and not including any benefits you get)

To secure your son/daughter's place on the trip, please make payment and provide your consent by **Friday 17**<sup>th</sup> **January 2025.** Please note that if you have paid and given permission online you do not need to return the attached consent form.

Places are limited to 60 and are allocated on a first come, first served basis. Early booking is advisable.

This is a fantastic opportunity for students to enjoy an extra-curricular experience aiding their learning in the classroom and I very much hope that your son or daughter will be able to join us.
