The morning began with an observation of the Post-16 assembly on a challenging and thought provoking topic that was timely and well received by students.		
Meeting 1 was with AHT Chris Bugh with a focus on the Post16 provision, challenges facing the school and the picture with regard to curriculum and teaching and learning at Post-16 prior to our lesson visits later in the day.		
Meeting 2 was with Adam Goodger regarding systems and procedures introduced at Post-16 to ensure that attitudes to learning, attendance, punctuality etc. continued to improve. Largely successful initiatives were quoted although some work needs to be undertaken around ensure systems escalate appropriately.		
We then conducted a series of lesson visits to KS5 classes which was informative in that it backed up the conversations we had earlier in the day with Chris. It is clear that the strengths and weaknesses at Post-16 are well known and steps are being taken to improve those areas identified.		
Moving on to the student panel, this was a cross section of the school, led by the student leadership team. Students were confident and articulate and were able to effectively point to the impact of their roles and spoke of their desire to continue.		

Finally we met with members of the Post-16 student support team – largely focusing on attendance which is lower than expected. Efforts are being made and systems put in place to ensure these increase but there also needs to be a clear escalation of procedures for any student with poor attendance.

Overall this as an informative and interesting visit to the school.
