## Work Experience Opportunity – Summer Holiday 2021

We are working in partnership with the Leicestershire Education Business Company (LEBC) to offer students the opportunity to apply for a work experience placement during the summer break in 2021. LEBC have been organising work placements for students across Leicestershire for more than 20 years. Their website is [www.leics-ebc.org.uk](http://www.leics-ebc.org.uk) if you would like to find out more about the organisation.

Work experience is a valuable activity that aims to give students an insight to the world of work; there is always a lot of value to be gained, even if the placement is not what the student was expecting. It helps prepare students for their future working lives.

The cost for your son/daughter to take part is £58 per placement. For this price LEBC will;

- Set up of the work experience placement trying to meet your son/daughter's preference including workplace assessment of health, safety and welfare arrangements.
- Send you a contract agreement which sets out the job description and generic young person's risk assessment which your son/daughter will take to interview.

Should a student wish to organise their own work placement LEBC will carry out all appropriate checks to ensure the placement is suitable and safe, on our behalf. This carries a cost of £51 and requires completion of an additional self-placement form.

LEBC have a contingency plan should work experience not be able to go physically ahead due to Covid-19 restrictions. If a student has to self-isolation or quarantine whilst they were supposed to be on work placement, LEBC will rearrange the placement so the experience is not lost. Should we have a period of lockdown stopping work experiences from going ahead, LEBC will have a repurposed work experience virtual programme; this will include local businesses setting challenges.

LEBC will then issue each student with their own login to the LEBC work experience website in order to fill out the application form. If your child would like to participate in work experience please follow this process:

1. They need to email me by Friday 1<sup>st</sup> October.
2. Once they have their login details they need to make their application by Friday 22<sup>nd</sup> October.
3. Payments will be assigned on Parentpay for £58 or £51 dependent on whether the student is undertaking a self-placement or one arranged by LEBC.
4. Once I receive notification that they have made an application, I will send out a consent form to their parent/carer to sign.
5. The deadline for this form and payment is Friday 5<sup>th</sup> November.
6. All consent forms should be returned to the Reception office by the due date, with the appropriate online payment made.
