DEED OF VARIATION
relating to a funding agreement

THIS DEED OF VARIATION is made on

BETWEEN:

- (1) The Secretary of State for Education (“**Secretary of State**”); and
- (2) Redmoor Academy (previously known as Redmoor High School Academy Trust), a charitable company incorporated in England and Wales with registered number 07992372 (“**Company**”)

together referred to as the “Parties”.

INTRODUCTION:

- (A) The Parties entered into a funding agreement dated 27 March 2012 (“**Funding Agreement**”) relating to the establishment, maintenance and funding of an independent school known as Redmoor High School Academy Trust (“the Academy”).
- (B) In reflection of the fact that the age range, capacity and name of the Academy have changed, together with a change to the Company’s name, the Parties now wish to vary and amend the terms of the Funding Agreement and wish to record their agreement as to such variations/amendments to the Funding Agreement by this Deed.

IT IS AGREED as follows:

1. Any word or phrase used in this Deed shall, if that word or phrase is defined in the Funding Agreement, bear the meaning given to it in the Funding Agreement
2. The Secretary of State and the Company agree that with effect from the date of this Deed the Funding Agreement shall be amended in accordance with Schedule 1 to this Deed.
3. As varied by this Deed, the Funding Agreement shall remain in full force and effect.
4. This Agreement shall be governed by and interpreted in accordance with English law.



SCHEDULE 1 - amendments to the Funding Agreement

1. The first sentence of clause 17 of the Funding Agreement shall be replaced with:

“The planned capacity of the Academy is 925 in the age range 11 - 16.”

2. All references in the Funding Agreement to “*Redmoor High School Academy Trust*” shall be replaced with “*Redmoor Academy*”.
