This template can be used for multiple purposes:

• It enables schools to effectively plan their use of the Primary PE and sport premium

 It helps schools to meet the requirements (as set out in guidance) to publish information on their Primary PE and sport premium

 It will be an effective document to support Ofsted inspections enabling schools to evidence progress in Physical Education (PE) and evidence swimming attainment, which forms part of the PE National Curriculum. We would recommend schools consider the Intent, Implementation and Impact of any spend, as examined within the Education Inspection Framework.

It is important that your grant is used effectively and based on school need.

Schools must use the funding to make additional and sustainable improvements to the quality of the PE, School Sport and Physical Activity (PESSPA) they offer. This means that you should use

they offer. This means that you should use the Primary PE and sport premium to:

- Build capacity and capability within the school to ensure that improvements made now will benefit pupils joining the school in future years
- Develop or add to the PESSPA activities that your school already offers.

The Primary PE and sport premium should not be used to fund capital spend projects; the school's core budget should fund these. Further detail on capital expenditure can be found in the updated Primary PE and sport premium guidance.

Although completing this template is not a requirement for schools, schools are required to publish details of how they spend this funding. Our participation in the 'Chance to Shine' program, lead by Durham Cricket Club, has raised the profile of school cricket. Young leaders who have participated in training, as well as staff who attended CPD sessions have introduced cricket at break times.

Provide a full complement of clubs throughout the year for Key Stage 1 and 2, identifying these pupils who are least active.

This academic year, after school clubs have taken into account feedback from our pupil surveys. Staff have identified those pupils not accessing clubs, and all of these pupils were offered places in at least one club. Where possible, we have used Pupil Premium funding to support those families struggling financially so that their pupils can attend clubs. Clubs have been very positive with most at full capacity or near full capacity, and a waiting list for some.

Re-evaluate the provision available next academic year (2023/24). Use pupil voice to support planning of and running of clubs that are most successful and promote a love of PE for those children who attend.

Continue to target least active pupils and their families.

What percentage of your current Year 6 cohort can swim competently, confidently and proficiently over a distance of at least 25 metres?	67%	Following the closure of our local pool, lessons had to be moved to another local pool. The number of pupils attending each lesson was limited. Very few of our pupils attend swimming lessons outside of the lessons they receive in curriculum time. A number of pupils have joined our school who had never had any swimming lessons before (our pupils swim in 3 consecutive years to try to combat this issue.)
What percentage of your current Year 6 cohort can use a range of strokes effectively [for example, front crawl, backstroke, and breaststroke]?	67%	
What percentage of your current Year 6 cohort are able to perform safe self-rescue in different water-based situations?	67%

Have you done this?	Yes	Top Up lessons were provided in the summer term for all of our Year 6 pupils using the data from their achievements in Year 5.

Yes	All staff who attend weekly swimming lessons have shadowed our swimming teachers, so that they can confidently support them on a weekly basis. Staff members who have already passed their Assistant Swimming Teacher Awards have provided informal CPD to address the particular needs of the pupils.
