AIM project: A registered charity set up in Manchester who have developed a range of tools for assessment and intervention with children and young people who display sexually harmful behaviour

TA-HSB was engaged in by almost half (46 per cent) of the children and young people accessing this service.

It was rare for children and young people to engage in TA-HSB alone (7 per cent of the sample) without also engaging in offline HSB (46 per cent).

Child sexual exploitation grooming models

- Peer on peer exploitation
- Exploitation through befriending and grooming
- The ‘boyfriend’/pimp model of exploitation
- The ‘party’ model

6 Stages of Child Grooming

- 1) *Targeting the victim*
- 2) *Gaining the victim's trust (Befriending)*
- 3) *Filling a need*
- 4) *Isolating the child*
- 5) *Sexualising the relationship*
- 6) *Maintaining control*



The internet – an inspiring resource which enables different ways, on a range of devices. However, the technology can be a challenge. You may sometimes feel uncertain about how to keep your child safe and protected while issues that your child may encounter on the internet risks into these 4 categories.

Conduct:

Children need to be aware of the impact footprint that they create on the internet. They should always consider privacy information safe and not share it with strangers. Children should be aware of their image and behaviours and how this can be done.

Content:

Young people's content is not suitable for children. Social networks, online games, blogs are aware that it might not be true or written. There can be legal consequences for using or doing.

Contact:

It is important for children to realise that what is added to an online account, you may be able to see. If you have concerns that a friend is able to access. If you have concerns that another person, it's vital that you tell it to the police. If you are worried, then tell them to the adult straight away if someone is bullying them or it.

Commercialism:

Young people's privacy and enjoyment of the internet is important. If you want to keep information private, learn how to block to use a family email address when filling in online forms.

There are real advantages in maintaining an open dialogue with your child about their internet use. Not sure where to begin? These conversation starter suggestions can help.

1 Ask your children to tell you about the websites and apps they like to use and what they enjoy doing online.

2 Ask them about how they stay safe online. What tips do they have for you, and where did they learn them? What is OK and not OK to share?

3 Ask them if they know where to go for help, where to find the safety advice, privacy settings and how to report or block on the services they use.

4 Encourage them to help someone! Perhaps they can show you how to do something better online or they might have a friend who would benefit from their help and support.

5 Think about how you each use the internet. What more could you do to use the internet together? Are there activities that you could enjoy as a family?


Childnet has created a resource which is designed to support teachers in exploring critical thinking online.


