1. Context and Aims

Relationship Sex and Education (**RSE**) is lifelong learning about relationships, sex, sexuality, emotions, and sexual health. It involves acquiring information, developing skills and forming positive beliefs, values and attitudes. Relationship and sex education should empower young people, build self-esteem, offer a positive and open view of sex and sexuality and support sexual self and mutual acceptance and respect.

RSE is firmly rooted in our Academy's Personal, Social, Health and Economic (**PSHE**) Curriculum and is also delivered as part of other curriculum areas such as Science, Physical Education and IT and through tutor time. This policy links with other Academy policies such as the Behavior policy, Curriculum policy, Safeguarding policy, Data protection policy, Internet and Acceptable use policy and Teaching and Learning policy.

Our local context:

Analysis of local data, information from network meetings and student voice have indicated the need for particular attention to:

- diversity of our community and high rates of deprivation;
- higher than national numbers of STIs;
- higher than national unwanted pregnancies;
- higher than national proportions of young people who do not have a trusted adult;
- the high proportion of children and young people who have 'spoken' online to somebody they don't know; and
- the high proportion of children and young people who have received online sexual images

Key Aims:

The aims of RSE at our Academy are to:

- Provide a framework in which sensitive discussions can take place;
- Prepare students for puberty, and give them an understanding of sexual development and the importance of health and hygiene;
- Help students develop feelings of self-respect, confidence and empathy;

- Create a positive culture around issues of sexuality and relationships;
- Teach students the correct vocabulary to describe themselves and their bodies; and
- To meet the needs of our students in relation to the local context.

2. Statutory requirements

As a secondary academy, we must provide RSE to all pupils under section 34 of the [Children and Social Work Act 2017](#).

In teaching RSE, we're required by our funding agreements to have regard to [guidance](#) issued by the secretary of state, as outlined in section 403 of the [Education Act 1996](#).

We also have regard to legal duties set out in:

- Sections 406 and 407 of the Education Act 1996
- Part 6, chapter 1 of the [Equality Act 2010](#)
- The Public Sector Equality Duty (as set out in section 149 of the Equality Act 2010). This duty requires public bodies to have due regard to the need to eliminate discrimination, advance equality of opportunity and foster good relations between different people when carrying out their activities

At Duke's Aldridge Academy we teach RSE as set out in this policy.

3. Policy development

This policy has been developed in consultation with staff, students and parents/carers. The consultation and policy development process involved the following steps:

- Review – a member of staff or working group pulled together all relevant information including relevant national and local guidance.

Staff consultation – all Academy staff were given the opportunity to look at the policy and make recommendations.

- Parent/stakeholder consultation – parents/carers and any interested parties were invited to attend a meeting about the policy
- As set out in the Statutory Guidance, during any consultation with Parents/Carers they will be given an opportunity to review examples of the materials and resources we will use as part of the delivery of the RSE curriculum, not just for reassurance and information but also to encourage parents to continue discussions of the issues raised in RSE at home
- Ratification – once amendments were made, the policy was shared with members of the Local Governing Committee and ratified.

4. RSE Definition

RSE is about the emotional, social and cultural development of students, and involves learning about relationships, sexual health, sexuality, healthy lifestyles, diversity and personal identity.

RSE involves a combination of sharing information, and exploring issues and values. RSE is not about the promotion of sexual activity.

5. Curriculum

Our curriculum overview is set out as per Appendix 1 but we may need to adapt it as and when necessary. See in particular section 6 below in relation to inclusion, access and entitlement for all.

As set out above, we have developed the RSE curriculum in consultation with parents, students and staff, taking into account the age, needs and feelings of students. If students ask questions outside the scope of this policy, teachers and relevant staff will respond in an appropriate manner, having due regard to their obligations under the Academy's Safeguarding Policy, so that students are fully

informed and don't seek answers online.

We will share all curriculum materials with parents and carers upon request.

6. Delivery of RSE

RSE is taught within the personal, social, health and economic (**PSHE**) education curriculum through lessons, assemblies and drop-down sessions. Ms Tuptuk will have an overview of the RSE curriculum and content.

Biological aspects of RSE are taught within the science curriculum, and other aspects are included in religious education (RE) with aspects of healthy living in PE and tutor time.

We are mindful of the law and legal requirements, taking care not to condone or encourage illegal political activity, such as violent action against people, criminal damage to property, hate crime, terrorism or the illegal use of drugs.

Students may also receive stand-alone sex education sessions delivered by a trained health professional. Some of these sessions will be in single-sex groups.

RSE focuses on giving young people the information they need to help them develop healthy, nurturing relationships of all kinds including:

- Families
- Respectful relationships, including friendships
- Online and media
- Being safe
- Intimate and sexual relationships, including sexual health

For more information about our RSE curriculum, see Appendices 1 and 2.

We consider whether any resources we plan to use:

- Are aligned with the teaching requirements set out in the statutory RSE guidance
- Would support students in applying their knowledge in different contexts and settings
- Are age-appropriate, given the age, developmental stage and background of our students
- Are evidence-based and contain robust facts and statistics
- Support our curriculum plan
- Are from credible sources
- Are compatible with effective teaching approaches
- Are sensitive to students' experiences
- Are relevant to our context and any emerging needs

Our RSE curriculum is also responsive, responding to concerns which may arise leading to additional lessons and/or assemblies to deal with the situation as quickly and effectively as possible.

All students will receive the full RSE programme, however, on occasion, it may be appropriate to provide opportunities for students to discuss matters further in single-sex groups or individually. However, this should not mean that there is any group which is omitted from aspects of RSE education. For example, boys should learn about menstruation as well as girls.

Inclusion, Access and Entitlement for All

At Duke's Aldridge Community Academy, we are committed to working towards equality of opportunity in all aspects of Academy life. We will make sure that our RSE programme is inclusive and we consider the needs of vulnerable groups in the planning and delivery of our curriculum.

Our students have different abilities based on their emotional and physical development, life experiences, literacy levels and learning abilities, and we aim to ensure that all students are able to access and be included in RSE.

Some students with SEND may be more vulnerable to abuse and exploitation than their peers, and others may be confused about what is acceptable behaviour. These students in particular will need to develop skills to reduce the risks of being exploited, and to learn what sorts of behaviour are, and are not, acceptable. Form tutors and other members of Staff delivering RSE will work with the SENDCO to ensure that differentiation appropriate to the individual students in their class is planned for all PSHE lessons. Students with special educational needs will be given extra RSE support by SEN staff.

Students with English as their second language will receive any required help from assigned staff to ensure that they can access the RSE curriculum.

We celebrate and recognise the diverse beliefs of our religious and minority ethnic communities and we value and celebrate cultural diversity. We explore assumptions about different cultural beliefs and values and encourage activities, which challenge stereotypes and misconceptions. We use a range of teaching materials and resources that reflect our cultural diversity and encourage a sense of openness and inclusiveness.

We accept that students and adults in our Academy may hold very different religious and cultural beliefs about some of the topics taught within the RSE curriculum.

We will encourage consultation and discussion with students, parent/carers and community leaders to ensure that we consider cultural, religious and linguistic needs in the development and review of our RSE policy and programme.

Whilst we will always try to work with parents/carers to accommodate their wishes, we accept that parents can exercise their right to withdraw their children from RSE, apart from where the topics are required to be taught under the National Curriculum for Science.

These areas of learning are taught within the context of family life taking care to ensure that there is no stigmatisation of children based on their home circumstances (families can include single parent families, LGBT parents, families headed by grandparents, adoptive parents, foster parents/carers amongst other structures) along with reflecting sensitively that some children may have a different structure of support around them (for example: looked after children or young carers).

We will also be mindful of the law and legal requirements, taking care not to condone or encourage illegal political activity, such as violent action against people, criminal damage to property, hate crime, terrorism or the illegal use of drugs.

We teach about these topics in a manner that:

- Considers how a diverse range of students will relate to them
- Is sensitive to students' experiences;
- During lessons, makes students feel:
 - Safe and supported
 - Able to engage with the key messages

We consider the best environment in which students learn about these topics in an environment that is appropriate for them, and give careful consideration to the level of adaptation needed, for example in:

- A whole-class setting
- Small groups or targeted sessions
- 1-to-1 discussions
- Digital formats

We will also give careful consideration to the level of differentiation needed

6.2 Use of resources

We will consider whether any resources we plan to use:

- o Are aligned with the teaching requirements set out in the statutory RSE guidance
- o Would support pupils in applying their knowledge in different contexts and settings
- o Are age-appropriate, given the age, developmental stage and background of our pupils
- o Are evidence-based and contain robust facts and statistics
- o Fit into our curriculum plan
- o Are from credible sources
- o Are compatible with effective teaching approaches
- o Are sensitive to pupils' experiences and won't provoke distress

7.Roles and responsibilities

7.1 The Local Governing Committee

The Local Governing Committee will approve this RSE policy, and hold the Principal to account for its implementation. A nominated member of the LGC will monitor the implementation of this policy.

The LGC nominated member is - Sandrine Paillasse.

7.2 The Principal

The Principal is responsible for ensuring that:

- RSE is taught consistently across the Academy
- All pupils make progress in achieving the expected educational outcomes;
- The subjects are well-led, effectively managed and well-planned;
- The quality of provision is subject to regular and effective self-evaluation;
- Teaching is delivered in ways that are accessible to all pupils with SEND;
- Clear information is provided for parents/carers on the subject content and the right to request that their child is withdrawn, as well as managing such requests; and
- The subjects are resourced, staffed and timetabled in a way that ensures that the school can fulfil its legal obligation

7.3 Staff

Staff are responsible for:

- A. Delivering RSE in a sensitive way and in accordance with this policy as well as other relevant Academy policies;

- B. Modelling positive attitudes to RSE;
- C. Monitoring progress of students to ensure that all students are accessing the RSE curriculum;
- D. Responding to the needs of individual students; and
- E. Responding appropriately to students whose parents wish them to be withdrawn from the non-statutory/non- science components of RSE.

Staff do not have the right to opt out of teaching RSE. Staff who have concerns about teaching RSE are encouraged to discuss this with the Principal.

RSE education will be delivered by staff timetabled to teach PSHE. The PSHE lead will have an overview of the RSE curriculum and content.

7.4 Students

Students are expected to engage fully in RSE and, when discussing issues related to RSE, treat others with respect and sensitivity.

7.5 Visitors

We welcome the support of visitors offering specialist support and links with the community to enhance the curriculum offer and support with specialist knowledge. The Academy nurse and other health professionals may be involved at different stages of the programme. Visitor sessions always complement the existing RSE provision and never replace or substitute teacher-led curriculum provision. All such visitors are carefully vetted by the PSHE lead.

We ensure that any visitors and external materials are appropriate and in line with KCSiE and our legal duties around political impartiality.

The Academy remains responsible for what is said to students. This includes making sure that any speakers, tools, and resources used don't undermine our fundamental British values of democracy, the rule of law, individual liberty, and mutual respect and tolerance of those with different faiths and beliefs.

Working With External Agencies:

We make appropriate checks and engage with external agencies to make sure that their approach to teaching about RSE is balanced, and it and the resources they intend to use:

- Are age-appropriate
- Are in line with students' developmental stage
- Comply with:
 - This policy
 - The [Teachers' Standards](#)
 - The [Equality Act 2010](#)
 - The [Human Rights Act 1998](#)
 - The [Education Act 1996](#)

We will:

- Only work with external agencies where we have full confidence in the agency, its approach and the resources it uses;

- Make sure that any speakers and resources enhance the intended outcome of the relevant part of the curriculum;
- Review any case study materials and look for feedback from other people the agency has worked with;
- Be clear on:
 - What they're going to say
 - Their position on the issues to be discussed
 - Ask to see in advance any materials that the agency may use
 - Know the named individuals who will be there, and follow our usual safeguarding procedures for these people
 - Conduct a basic online search and address anything that may be of concern to us, or to parents and carers
 - Check the agency's protocol for taking pictures or using any personal data they might get from a session
 - Remind teachers that they can say "no" or, in extreme cases, stop a session
 - Make sure that the teacher is in the room during any sessions with external speakers
 - Make all external materials available for parents and carers

We won't, under any circumstances:

- Work with external agencies that take or promote extreme political positions
- Use materials produced by such agencies, even if the material itself is not extreme

8.0 Parents' right to withdraw/Working With Parents

The RSE curriculum aims to complement and support the education provided to our students at home around the same matters. Parents and carers can access the RSE curriculum on the Academy website and are informed regularly of the content of the PSHE curriculum to be covered, including a letter home in advance of RSE lessons on particular topics. Parents and carers are able to discuss issues relating to RSE with their child's form tutor during parent's evenings, or by directly contacting their child's teacher. All parents are also invited to Parent Forums to seek more information on RSE education at our Academy. We will devote one parents' forum per year to RSE. [Before the start of certain topics in the RSE curriculum, all parents will be written to explaining what will be taught, and reminding them of their rights to withdraw their child from the non-statutory/non-science components of sex education within RSE.]

Parents have the right to withdraw their children from the non-statutory/non-science components of sex education within RSE up to and until 3 terms before the child turns 16. After this point, if the child wishes to receive sex education rather than being withdrawn, the Academy will arrange this.

Requests for withdrawal should be put in writing using the form found in Appendix 3 of this policy and addressed to the Principal.

A copy of withdrawal requests will be placed in the student's educational record. The Principal will discuss the request with parents and take appropriate action.

Alternative work will be given to students who are withdrawn from sex education.

9 Training

Staff are regularly trained on the delivery of RSE, this may include the use of external visitors to support training and delivery. The number of staff delivering PSHE is limited as much as possible [

Teachers will be offered support and training to deliver the programme sensitively and effectively. This may involve support from the PSHE Lead, the senior leadership team, outside agencies and the academy nurse. The training provided is also based on staff confidence on the delivery of topics and is monitored through staff voice.

10. Monitoring arrangements

The delivery of RSE is monitored by the PSHE lead, through: Learning walks, book scrutinies, student voice, lesson observations.

At the end of the scheme of work, students will complete a questionnaire in order to identify any gaps in knowledge that need to be re-addressed and highlight any adjustments that need to be made to the RSE curriculum

Students' development in RSE is monitored by class teachers as part of our internal assessment systems.

This policy will be reviewed by the Academy *biennially*. At every review, the policy will be approved by the Local Governing Committee.

10.1 Specific Issues

We recognise that some aspects of RSE for teachers, students, parent/carers and the wider Academy community may be considered sensitive or challenging. What constitutes a sensitive/challenging issue is likely to vary according to the individual, group, place or context. We respect the varied beliefs and values held by our Academy community. However, personal beliefs and attitudes will not influence the teaching of RSE. Teachers and all those contributing to RSE are expected to work within our agreed values framework as described in this policy and supported by current legislation and guidelines.

Teachers will be offered support and training to deliver the programme sensitively and effectively. This may involve support from the PSHE Lead, the senior leadership team, outside agencies and the academy nurse.

Students may ask questions or seek information about specific issues. It is Academy policy to address these questions and provide information in a straightforward age and maturity appropriate way. The Academy nurse may be used to support this process. In this way, students will be offered reassurance and will have misinformation corrected.

10.2 Confidentiality and Safeguarding/Child Protection

The basic principle is that young people, including those under 13, have the same right to confidentiality as adults.

Duke's Aldridge Academy is committed to acting in the best interest of all the individuals within the Academy community. Relationship and sex education should take place within a safe and supportive environment that facilitates relevant discussion. Confidentiality contributes to this and will be used as a ground rule for all RSE lessons.

As part of discussions about confidentiality, all students will be informed of the limits to teacher confidentiality and will be told that teachers can keep confidentiality except when the teacher is concerned about their safety or that of another child. In accordance with the Academy's Safeguarding Policy, if a teacher believes that a child is at risk or in danger, they must report that in the usual way through CPOMS/the Designated Safeguarding Lead.

Students will also be discouraged from making personal disclosures during RSE lessons. As an integral part of RSE, students may be made aware of confidential sources of information.

As part of RSE students will be encouraged to talk to a trusted adult, possibly a parent or carer, if they are having sex or contemplating doing so. Students will also be reminded that the age of consent for heterosexuals and same sex relationships is currently 16.
