COMPLAINTS PROCEDURE

ADVICE AND INFORMATION FOR PARENTS, CARERS & GUARDIANS

Studley High School is an Academy Trust School

The headteacher, staff and governors of Studley High School want to work with you to establish a good parent / school relationship. They will inform you about the school's policies and your child's progress. However, there may be times when you, as a parent, carer or guardian, will have comments, suggestions or complaints to make.

Your query may concern the curriculum, it may involve things for which the Local Authority has some responsibility or you may have a concern about a particular incident, which you understand has happened at the school.

Whatever the issue, the important thing is to talk to someone at the school as soon as you can. It may be all that you need to do to solve the problem. If you are still unhappy after that, this policy tells you how you can take the matter further. It tells you what will happen and whom to contact.

Problems are more easily resolved if they are raised as soon as possible after something has happened. The formal procedure only covers complaints about incidents which have happened in the previous three months. This may not apply if there are obvious reasons why the incident could not have been taken up earlier.

There are some complaints that cannot be followed up through these procedures. Separate procedures exist for complaints, for instance, on staff conduct, admission to or exclusion from school, statements of special educational need, and on religious education and collective worship. If you take your concern informally to the school first, the headteacher can advise you if it is a matter that will be dealt with in a different way.

Stage 1 - The Informal Stage

- 1 If you have a query please follow the advice given below as this will be the most appropriate member of staff to assist you. They will either respond immediately or as soon as they have the necessary information. You will be given a date by which they will get back to you.

Contact either by phone, in writing, or a visit by appointment, in the first instance, to the following :

- i Your child's Form Tutor,
- ii Your child's Pastoral Manager
- iii The Assistant Headteacher linked to your child's House.
- iv (a) The Assistant Headteacher, Teaching and Learning, for matters connected with pupils' teaching and learning, or
(b) The Safeguarding Lead for all other matters i.e. pastoral concerns.
- v The Deputy Headteacher
- vi The Headteacher
- vii If parents still have concerns these should be put in writing and addressed to the Chair of Governors, c/o Studley High School.

- 2 Please note: If you contact a member of the school's governing body they will ask you to contact the Headteacher or the appropriate member of staff. This is to help you start at the right place and leave the governors free for possible involvement at a later stage.

- 3 If appropriate, the Headteacher may suggest that you talk to an LA officer.

Stage 2 - The Formal Stage

- 4 Most complaints will have been resolved by this stage. If you are still unhappy the next step is to make a formal complaint to the governing body.
- 5 You can write a letter or use the form at the end of this booklet to record your complaint.
- 6 You should send your complaint to the Chair of Governors of the school. You may wish to keep a photocopy to use later. It is considered courteous to copy this to the Headteacher.
- 7 The Chair of Governors or a nominated Governor will review the Complaint to be certain that the matter has been appropriately dealt with at Stage 1.
- 8 Your complaint will be acknowledged and you will be asked to suggest dates and times for a hearing. You will be given the opportunity to supply further information in writing at least 5 school days before the hearing.
- 9 The Clerk to the Governors will confirm in writing the time, date and venue for the hearing. You may take a friend or representative with you as well as an interpreter, should one be required.
- 10 Four school days before the hearing the Clerk will send you any papers submitted for the consideration of the Panel including the original complaint.
- 11 At the hearing the Chair of the Panel will introduce the Panel members to you and remind you of the following process for the hearing.
- 12 An opportunity for you to speak to the Panel about your complaint.
- 13 The Governors on the Panel may ask you questions about what you have said or written.
- 14 You will be invited to make a final comment and indicate how you might hope the matter would be resolved.
- 15 You will then be free to leave the school.
- 16 The Panel will invite the Headteacher to join them in order to outline the school's position.
- 17 The Governors on the Panel may ask the Headteacher questions about what has been said or put in writing.
- 18 The Headteacher will have an opportunity to make a final statement.
- 19 The Headteacher will leave the Hearing.
- 20 The Panel will discuss what they have heard and reach a decision.
- 21 The Chair of the Panel will write to you and the Headteacher within three school days of the Hearing to let you know the outcome.
- 22 The letter from the Chair of the Panel will tell you how to proceed if you are not satisfied with the outcome.

Stage 3 - The Secretary of State

- 23 If you are still not happy, you can address your complaint to the Secretary of State, Department for Education and Skills, Sanctuary Buildings, Great Smith Street, London, SW1P 3BT. You should put your complaint in writing and enclose copies of your original complaint and any other relevant papers.
- 24 The Secretary of State will inform you of how your complaint will be handled.
