KS4 - Directed Pathway BTEC Personal and Social Development (PSD)

At KS4, we offer BTEC PSD to those students who are not engaged in subject specific study.

BTEC PSD is an accredited qualification which is available from Personal Progress to Level 1. The students will develop skills in different areas and the units of study are personalised at the student's level.

The areas of study include:

- Communication
- Skills for independent living
- Engaging with the world around you
- Skills for the workplace

Students progress in this area of study to further education and independent living.

As a local community inclusive school, the flexible approach to the education of our SEND students is one that strives to offer the best quality teaching, assistance and support. Focusing on quality education for enhanced inclusion implies identifying strategies for overcoming or eliminating the barriers to full participation for our students with SEND.

Eastlea's BTEC PSD curriculum offer will take into consideration all areas of study for our SEND students: the annual review outcomes, EHCP outcomes and the specific targets set by the other professionals and how all can be encompassed into the school long term plan, according to the student's individual outcomes.

All staff working with our KS4 students in BTEC PSD will undertake specific training and will be provided with specific strategies in order to meet the learning, medical, physical and sensory needs of the student.

The observation and assessment of the students' in BTEC PSD will take place at different levels in a range of contexts, such as: within a familiar environment with familiar and unfamiliar members of staff and within an unfamiliar context with familiar and unfamiliar members of staff (e.g. educational visits, swimming and rowing, etc.)
