## **About the General Data Protection Regulation (GDPR) in relation to Photography/Filming Consent at Bosworth Academy.**

In order to comply with new GDPR legislation, we have to ensure that we have explicit written consent from parents/guardians of every student at Bosworth Academy under the age of 18 that we wish to take photography and footage of. Under GDPR, it is our responsibility to outline your rights as the parent/guardian. This includes:

### **The right to be informed (articles 13 and 14)**

This means that we must state how we might use photography and/or footage of your child. These methods of use are listed overleaf.

### **The right to access (article 15)**

This grants you the right to access your child's personal data (photography and/or footage) on request, and receive confirmation regarding how these are being used.

### **The right to erasure (article 17)**

This grants you the right to request photography and/or footage of your child to be removed from the Bosworth Academy website; the LiFE Multi-Academy Trust website; our social media profiles such as Facebook, Twitter and YouTube; and future versions of printed materials such as prospectuses and leaflets.
