Instrument of Government

Hampstead Parochial Church of England Primary School

- 1. The name of the school is Hampstead Parochial Church of England Primary School.
- 2. The school is a voluntary aided school.
- 3. The name of the Governing Body is the Governing Body of Hampstead Parochial Church of England Primary School.
- 4. The Governing Body shall consist of:
 - 4.1. The Headteacher of Hampstead Parochial Church of England Primary School;
 - 4.2. Two parent governors, elected from among the parents of registered pupils at the school or a person who is appointed as a parent governor in accordance with the School Governance (Constitution) (England) Regulations;
 - 4.3. One local authority governor, nominated by the London Borough of Camden, as Local Authority and appointed by the Governing Body;
 - 4.4. One staff governor, elected from among the employees of the school by persons employed by the school; and
 - 4.5. Seven foundation governors; appointed in accordance with clause 6.
- 5. The total number of governors in the Governing Body is twelve.
- 6. The foundation governors shall be appointed as follows:
 - 6.1. Two governors shall be appointed by the London Diocesan Board for Schools;
 - 6.2. Two governors shall be appointed by the St John-at-Hampstead Parochial Church Council;
 - 6.3. Two governors shall be appointed by the North Camden Deanery Synod; and
 - 6.4. One ex-officio foundation governor.
- 7.1. The ex-officio foundation governor will be the holder of the office of The Vicar of St John-at-Hampstead Church.
- 7.2. The Archdeacon of Hampstead shall be entitled to appoint a foundation governor to act in the place of the ex-officio governor whose governorship derives from the office name in clause 7.1 above, in

the event that the ex-officio governor is unable to, or unwilling to, act as a foundation governor, or has been removed from office in accordance with the School Governance (Constitution) (England) Regulations.

- 8. The Archdeacon of Hampstead shall be entitled to request the Governing Body to remove the exofficio foundation governor, referred to in clauses 6.4, 7.1 and 7.2 above, and to appoint a substitute governor.
- 9. Recognising its historic foundation, the school will preserve and develop its religious character in accordance with the principles of the Church of England and in partnership with the Church at parish and diocesan level. The school aims to service its community by providing an education of the highest quality within the context of Christian beliefs and practice. It encourages an understanding of the meaning and significance of faith, an acceptance of those of different faiths or none and promotes Christian values through the experience it offers to all its pupils.
- 10. The term in office for all governors shall be four years.
- 11. This Instrument of Government comes into effect on 301 Occombor 2018
- 12. This Instrument of Government was made by the order of the London Borough of Camden on Sth November 2018
- 13. A copy of this Instrument of Government must be supplied to every member of the Governing Body and the London Diocesan Board for Schools.
