Use of Transport	Staff Pupils Others	Infection Control	<ul style="list-style-type: none"> <li>• If the school has 3 or more positive cases, and those people have been in close contact with others in the school, facemasks will be worn in enclosed and crowded spaces where you may come into contact with people you don't normally meet.</li> <li>• It is important to ensure vehicles are well ventilated when occupied, by opening windows and ceiling vents. The need for increased ventilation while maintaining a comfortable temperature should be balanced.</li> </ul> <p>On dedicated transport:</p> <ul style="list-style-type: none"> <li>• It is recommended that children and young people aged 11 and over continue to wear a face covering when travelling to secondary school or college.</li> </ul>	MED		✓

|  |  | <ul style="list-style-type: none"><li>• It is no longer recommended maximising distance and minimising mixing, but unnecessary risks such as overcrowding should be minimised.</li><li>• Children, young people and adults should follow <a href="#">public health advice</a> on when to self-isolate and what to do.</li><li>• They should not board dedicated transport or public transport if they have symptoms or other reasons requiring them to stay at home due to the risk of them passing on COVID-19.</li><li>• If a child or young person develops COVID-19 symptoms, however mild, while at school, they will be sent home.</li><li>• They should avoid using public transport and, wherever possible, be collected by a member of their family or household.</li><li>• In exceptional circumstances, if parents or carers cannot arrange to have their child collected, and it is age-appropriate and safe to do so, the child should walk, cycle or scoot home. If disposable cloths are not available use once and then put in wash.</li> <li>• Regular cleaning of surfaces will reduce the risk of spreading the virus.</li> <li>• All used cloths thrown away to be double bagged and then placed in a secure area i.e. lockable bin.</li> </ul>	MED		✓

			<p>'self-isolation' period) has passed, in line with national guidance.</p> <ul style="list-style-type: none"> <li>• Pupils who are unwell are not taken on school trips or permitted to enter public areas used for teaching, e.g. swimming pools.</li> <li>• Parents notify the school if their child has an impaired immune system or a medical condition that means they are vulnerable to infections.</li> <li>• The school in liaison with individuals' medical professionals where necessary, reviews the needs of pupils who are vulnerable to infections.</li> <li>• Any additional provisions for pupils who are vulnerable to infections are put in place by the headteacher, in liaison with the pupil's parents where necessary.</li> </ul>

|  |  | <ul style="list-style-type: none"><li>• Any pupil or member of staff who displays signs of being unwell, such as having a cough, fever or a loss or change to their sense of smell or taste, and believes they have been exposed to coronavirus, is immediately taken out of the class and placed in an area where they will not come into contact with others and are supervised at all times.</li><li>• For pupils the relevant member of staff calls for emergency assistance immediately if pupils' symptoms worsen.</li><li>• The parents of unwell pupils are informed as soon as possible of the situation by a relevant member of staff.</li><li>• Where contact with a pupil's parents cannot be made, appropriate procedures are followed in accordance with those outlined in governmental guidance.</li><li>• Unwell pupils who are waiting to go home are kept in an area where they can be at least two metres away from others.</li><li>• Areas used by unwell staff and pupils who need to go home are appropriately cleaned once vacated, using a disinfectant and care to be taken when cleaning all hard surfaces.</li><li>• If unwell pupils and staff are waiting to go home, they are instructed to use different toilets to the rest of the school to minimise the spread of infection.</li><li>• Any pupils who display signs of infection are taken home immediately, or as soon as practicable, by their parents – the parents are advised to contact NHS 111 immediately or call 999 if the pupil becomes seriously ill or their life is at risk.</li></ul> |  |  |

			<ul style="list-style-type: none"> <li>Any members of staff who display signs of infection are sent home immediately and are advised to contact NHS 111 immediately or call 999 if they become seriously ill or their life is at risk.</li> <li>Any medication given to ease the unwell individual's symptoms, e.g. Paracetamol, is administered in accordance with the Administering Medications Policy.</li> </ul>			
Asymptomatic testing Summer School	Pupils Staff	Infection control	<ul style="list-style-type: none"> <li>Schools will only provide tests for twice weekly asymptomatic testing for pupils and staff over the summer period if they are attending school settings.</li> <li>Staff should undertake twice weekly home tests whenever they are on site until the end of September when this will be reviewed</li> </ul>	MED		✓
<b>Secondary School Pupils</b> Asymptomatic testing Autumn Term	Pupils Staff	Infection Control	<ul style="list-style-type: none"> <li>All secondary school pupils who choose to should receive <b>2 on-site</b> lateral flow device tests, 3 to 5 days apart, on their <b>return</b> in the autumn term.</li> <li>Settings may commence testing from 3 working days before the start of term and can stagger return of pupils across the first week to manage this.</li> <li>Pupils should then continue to test twice weekly at home until the end of September, when this will be reviewed.</li> <li>New intake of year 7 will be offered the 2 tests at an ATS at the beginning of the autumn term when they start at their secondary school.</li> <li>Schools should also retain a small asymptomatic testing site (ATS) on-site until further notice so they can offer testing to pupils who are unable to test themselves at home.</li> </ul>	MED		✓

Positive Cases	Pupils Staff	Infection control	<ul style="list-style-type: none"> <li>School no longer need to do contact tracing as close contacts will be identified via NHS Test and Trace.</li> <li>School will support NHS Test and Trace when required to help identify close contacts</li> </ul> <p><b>From 16<sup>th</sup> August 2021</b></p> <ul style="list-style-type: none"> <li>From 16 August 2021, children <b>under the age of 18 years</b> old <b>will no longer be required</b> to self-isolate if they are contacted by NHS Test and Trace as a close contact of a positive COVID-19 case.</li> <li>Instead, children will be contacted by NHS Test and Trace, informed they have been in close contact with a positive case and advised to take a PCR test.</li> <li>We would encourage all individuals to take a PCR test if advised to do so.</li> </ul> <p><b>Over 18 years of age</b></p> <ul style="list-style-type: none"> <li>18-year-olds will be treated in the same way as children <b>until 6 months after their 18th birthday</b>, to allow them the opportunity to get fully vaccinated. At which point, they will be subject to the same rules as adults and so if they choose not to get vaccinated, they will need to self-isolate if identified as a close contact.</li> </ul>	MED	✓

			<ul style="list-style-type: none"> <li>Continue to have a role in working with health protection teams in the case of a local outbreak. If there is an outbreak in a setting or if central government offers the area an enhanced response package, a director of public health might advise a setting to temporarily reintroduce some control measures.</li> </ul> <p><b>Staff / Pupils</b></p> <ul style="list-style-type: none"> <li>with a positive lateral flow test result should self-isolate in line with the stay at home guidance and get a PCR test to check if they have COVID-19 and continue to self-isolate</li> <li>If the PCR test is taken within 2 days of the positive lateral flow test, and is negative, it overrides the self-test and the pupils/staff can return to school as long as the individual doesn't have COVID-19 symptoms</li> </ul>			
Poor management of infectious diseases	Staff Pupils Others	Lack of infection control	<ul style="list-style-type: none"> <li>Staff are instructed to monitor themselves and others and look out for similar symptoms if a pupil or staff member has been sent home with suspected coronavirus.</li> <li>Staff are vigilant and report concerns about their own, a colleague's or a pupil's symptoms to the Headteacher or SLT as soon as possible. .</li> <li>The school is consistent in its approach to the management of suspected and confirmed cases of coronavirus.</li> <li>The school is informed by pupils' parents when pupils return to school after having coronavirus – the school informs the relevant staff.</li> <li>Staff inform the headteacher when they plan to return to work after having coronavirus.</li> </ul>	MED		✓

Hospitalisation could indicate increased severity of illness or a new variant of concern. Settings may be offered public health support in managing risk assessments and communicating with staff and parents.</li> <li>• Settings may wish to seek additional public health advice if they are concerned about transmission in the setting.</li> </ul>

Lack of communication	Staff Pupils Others	Unsafe Practices	<ul style="list-style-type: none"> <li>• The school staff reports immediately to the headteacher about any cases of suspected coronavirus, even if they are unsure.</li> <li>• The headteacher contacts the local HPT or follows the advice given from and discusses if any further action needs to be taken.</li> <li>• Schools put into place any actions or precautions advised by their local HPT.</li> <li>• Schools keep staff and parents adequately updated about any changes to infection control procedures as necessary.</li> </ul>	MED		✓
Admitting children into school	Pupils Staff	Infection Control	<ul style="list-style-type: none"> <li>• In most cases, parents and carers will agree that a pupil with symptoms should not attend the school, given the potential risk to others. If a parent or carer insists on a pupil attending your school, you can take the decision to refuse the pupil if, in your reasonable judgement, it is necessary to protect other pupils and staff from possible infection with COVID-19.</li> <li>• Your decision would need to be carefully considered in light of all the circumstances and current public health advice.</li> </ul>	MED		✓
CEV children	Pupils Staff	Infection control	<ul style="list-style-type: none"> <li>• All CEV children should attend their education setting unless they are one of the very small number of children under paediatric or other specialist care who have been advised by their GP or clinician not to attend</li> </ul>	MED		✓

Admitting people into school	Pupils Staff	Infection control	<ul style="list-style-type: none"> <li>• Pupils, staff and other adults <b>should not</b> come into school if they have symptoms, have had a positive test result or have been instructed to quarantine</li> <li>• Anyone staff or pupils within the school who appear to have COVID-19 symptoms are sent home, advised to avoid using public transport and, wherever possible, be collected by a member of their family or household and to follow public health advice</li> <li>• In the case of a pupil awaiting collection, they should be taken to a room away from other pupils and supervised</li> <li>• If the member of staff is in close contact with the child then they should wear appropriate PPE</li> <li>• A window should be opened for fresh air ventilation if possible</li> <li>• Any rooms that have been used for this purpose should be cleaned after they have left</li> <li>• As anyone within the household should follow the PHE guidance for households with possible or confirmed COVID-19 infection, then any siblings within the school will be identified and also sent home.</li> </ul>	MED		✓

Out of school settings will not be expected to undertake contact tracing.</li> <li>• Individuals are not required to self-isolate if they are a close contact of someone with COVID-19 if they are fully vaccinated, below the age of 18 years and 6 months, taking part in an approved COVID-19 vaccine trial or are unable to get vaccinated for medical reasons. Instead they will be advised to take a PCR test.
