Christ the King Catholic Primary School Nursery 30 Hour Nursery Provision

Parent-School Agreement

The Government introduced 30-hour childcare provision to support working parents with childcare.

Information detailing the criteria for eligibility for this scheme is available by visiting: <https://www.gov.uk/30-hours-free-childcare>

You will be asked to input information about your personal circumstances to see if you qualify for the 30-hour provision.

If you do qualify, you will be given a code which you should bring to our School Nursery, together with your National Insurance (NI). The school office will check the code's eligibility and we will then confirm whether a 30-hour place can be given. There are a limited number of 30-hour places available.

Parents will be asked to pay £4 per day to cover lunchtime staffing.

When you can apply

When your child turns 3	When they can get 30 hours from	Recommended time to apply
1 September to 31 December	Term starting on or after 1 January	15 October to 30 November
1 January to 31 March	Term starting on or after 1 April	15 January to 28 February
1 April to 31 August	Term starting on or after 1 September	15 June to 31 July

What the 30-hour provision looks like in our Nursery

- **Parents will be asked to pay £4 per day to cover lunchtime staffing.**
- You will be asked to provide your child with a healthy packed lunch and a drink.
- If your child is absent from Nursery the daily £4 cost will still apply.
- You can either pay online or pay in cash each week at the school office. If you wish to pay online please use ParentPay
- You will need to reapply for your 30-hour code every three months and notify school. More information about this process is available on the above link.
