Election of Parent Governor: Declaration of Eligibility and Permission to Carry Out Checks Following Election

The appointment of Parent Governors is subject to statutory legislation and the Trust's own articles of association and scheme of delegation (Referenced in brackets). Therefore, please read the following carefully before signing the declaration overleaf. **If you do not meet all of these criteria, then you are disqualified from election as a parent governor.**

- **I am** aged 18 Or over ^{SD6.5.1}
- **I am not** a current student of the school^{SD6.5.1}
- **I am not** incapable by reason of mental disorder, illness or injury of managing or administering my own affairs.^{SD6.5.2}
- **I have not** had my estate sequestrated (temporarily repossessed) and the sequestration has not been discharged, annulled or reduced.^{SD6.5.4.1} **I am not** the subject of a bankruptcy restriction order or an interim order.^{SD6.5.4.2}
- **I am not** subject to a disqualification order or a disqualification undertaking under the Company Directors Disqualification Act 1986 or to an order made under section 429(2)(b) of the Insolvency Act 1986 (failure to pay under county court administration order).^{SD6.5.5}
- **I am not** ineligible by virtue of any provision in the Companies Act 2006 or disqualified from acting as a trustee by virtue of Section 178 of the Charities Act 2011 (or any statutory re-enactment or modification of that provision).^{SD6.5.6}
- **I have not** been removed from the office of a charity trustee or trustee for a charity by an order made by the Charity Commission or the High Court on the grounds of any misconduct or mismanagement in the administration of the charity for which I was responsible, or to which I was privy, or which by my conduct contributed to or facilitated.^{SD6.5.8}
- **I am not** subject to a direction of the Secretary of State under Section 142 of the Education Act 2002 or to any other disqualification, prohibition or restriction which takes effect as if contained in such a direction.^{SD6.5.8.1}
- **I am not** included in the list kept by the Secretary of State under Section 1 of the Protection of Children Act 1999,^{SD6.5.8.3}
 - nor disqualified from working with children in accordance with Sections 28, 29 or 29A of the Criminal Justice and Court Services Act 2000,^{SD6.5.8.3}
 - or barred from regulated activity relating to children (within the meaning of Section 3(2) of the Safeguarding Vulnerable Groups Act 2006.^{SD6.5.8.4}
 - or disqualified from registration under Part 2 of the Children and Families (Wales) Measure 2010 or child minding or providing day

- or disqualified from registration under Part 3 of the Childcare Act 2006,^{SD6.5.8.6}
- or disqualified under Childcare (Disqualification) Regulations 2009.^{SD6.5.8.7}
- **I have not** been convicted of an offence involving violence, dishonesty or deception, or any sexual offence which is not a protected offence,^{SD6.5.9.1} ○
Or convicted of causing a nuisance or disturbance on school and/or educational,^{SD6.5.9.2}
 - Or sentenced to imprisonment (whether suspended or not), in the UK or elsewhere, for a period of not less than three months.^{SD6.5.9.3}
- **I have not**, at any time, been convicted of any criminal offence, excluding any that have been spent under the Rehabilitation of Offenders Act 1974 as amended, and excluding any offence for which the maximum sentence is a fine or a lesser sentence except where a person has been convicted of any offence which falls under Section 178 of the Charities Act 2011.^{SD6.5.10}
