call social care First Point of Contact (FPOC): 03456 789021/ 03456 789040 (out of hours)

Or contact NSPCC: 0808 800 5000/ police 101/ 999 (if at immediate risk)

- If you are a member of the staff team, please refer to your department lead as they are all deputy Designated Safeguarding Leads(DSL).
- If you are a member of staff, you must report your concern onto the online system, My Concern. If you are unable to access the online system, complete a concern form and hand to a DSL (Disclosure forms are available on the website and in accessible key areas around all sites).
- If you are a parent/carer or visitor, please speak to any member of staff and they will help you find a DSL to talk to about your concern.

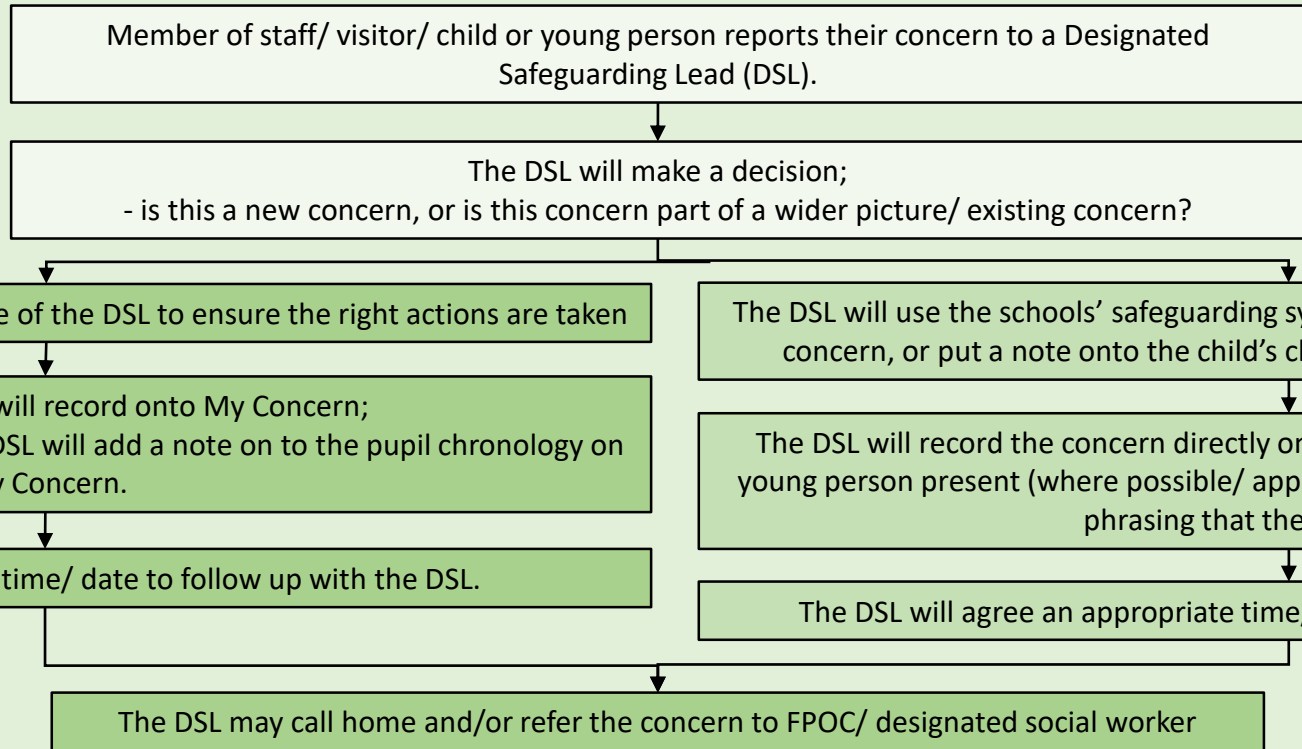

Process for reporting a safeguarding concern:



- If the department DSL is unavailable, please report the concern to any DSL as soon as possible. If you are in need of direct support please report the concern to FPOC (0345 6789021/ 03456 789040 (out of hours) / NSPCC (0808 800 5000)/ police (101/ 999 – in the case of an emergency/ immediate risk).
- Any concerns about an adult in a position of trust (a member of staff) must be taken to the Principal (via a DSL if the Principal is unavailable).
