ACET Trustees

The Board of Trustees manages the business of the academy trust and its focus is on the three core functions of governance:

- **ensuring clarity of vision, ethos and strategic implementation;**
- **holding executive leaders to account for the educational performance of the organisation and its pupils, and the appraisal of staff;**
- **overseeing the financial performance of the organisation and making sure its money is well spent.**

The Board of Trustees also has two sub committees: Audit & Finance and Appraisal and Remuneration.

ACET Local Governing Bodies

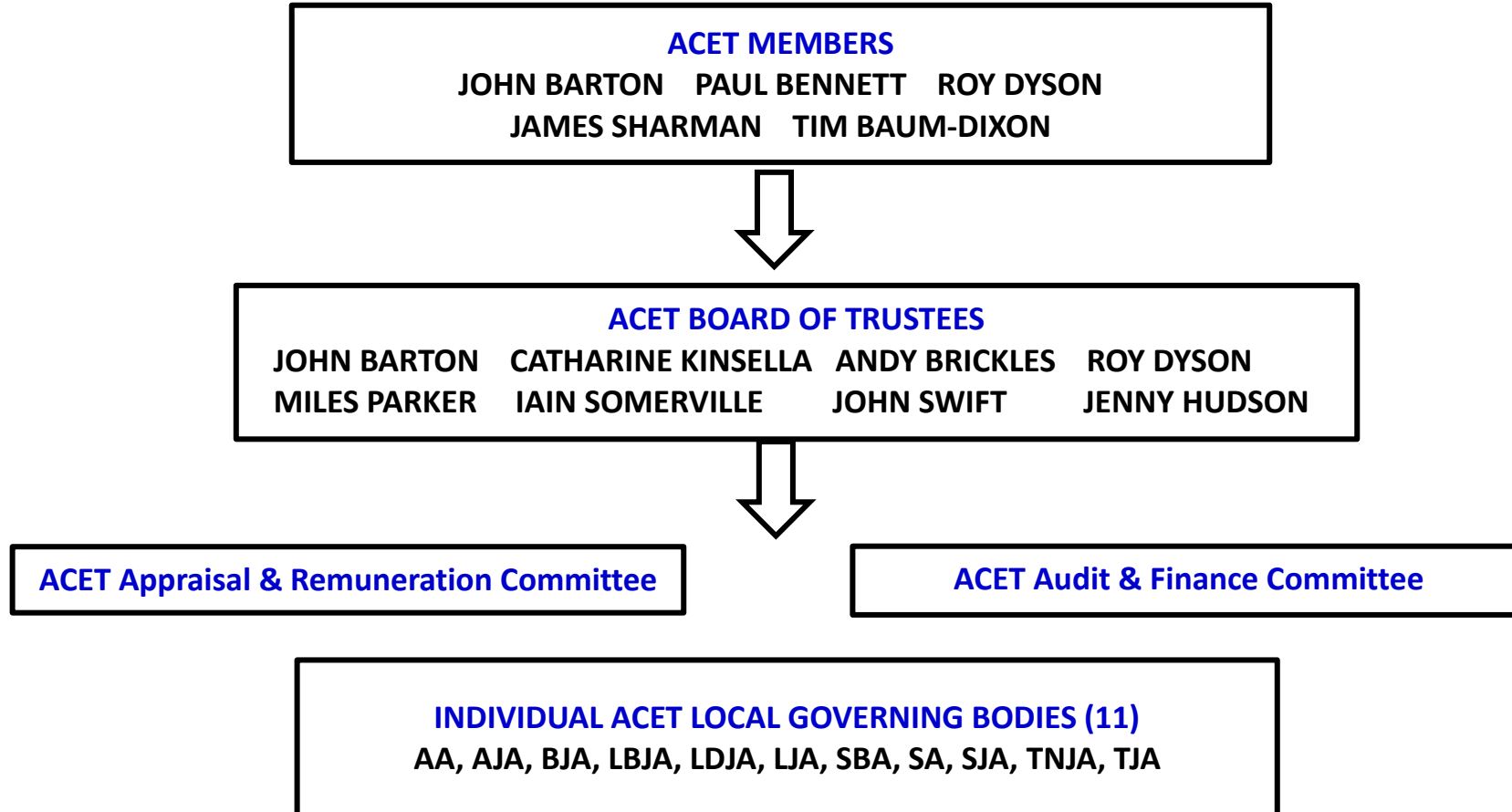
Each academy has a Local Governing Body which meets every half term. Local Governing Bodies have delegated responsibilities from the Board of Trustees for:
