500 CLUB RULES

PURPOSE

The purpose of the 500 Club is to raise funds. The money will be paid into the School's bank account and used to meet funding requests from the school, providing equipment, resources and opportunities for pupils.

RULES

1. For a cost of 10 per month (i.e. per draw) you will be allocated one number between 1 and 500.
2. A draw will be made every month, one month in arrears.
3. The prizes will total 25% of the annual income.
4. The 500 Club is a private lottery and is open to all parents, carers, staff and friends of the School. Anyone age 18 or over can join.
5. Payments must be made by standing order One month's notice is required for cancellation.
6. Member's numbers will only be entered if their subscription is up to date.
7. The draw shall be made by the Head Teacher or, in her absence, a Senior member of staff during the last week of each month.
8. The winning cheque will be posted to the address on your membership application within one week of the draw.
9. The name and numbers for each month's winners will be posted in the school school's website, and Facebook page.
10. The 500 Club will be run by the School. In case of any dispute the decision of the Senior Leadership Team is final.
11. Unless otherwise advised, a member will be deemed to have left the 500 Club if his/her subscription renewal remains unpaid for a period of one month and their number may be sold to someone on the reserve list.
12. If a winner cannot be contacted, the winnings will be placed into School funds after six months.
